MINUTES OF REGULAR BOARD MEETING DECEMBER 7, 1995 CHICAGO, ILLINOIS

After calling the meeting to order, Acting Chairman, J. Theodore Meyer asked the Clerk for a roll call and all Board Members answered present except for Chairman Claire Manning, who was absent due to illness.

In R96-2, 15% ROP Plan: Clean-up Part I: Amendments to 35 Ill. Adm. Code 219.585(a) and 219.Appendix E, a Proposed Rule, Second Notice, Opinion and Order was adopted by a vote of 5-1. J. Theodore Meyer dissented. (RCF)
