FEBRUARY 27, 1992 CHICAGO, ILLINOIS**

All Board Members were present. After calling the meeting to order, Chairman Marlin introduced Dr. G. Tanner Girard, a newly appointed Board Member.

An Opinion and Order was adopted in #89-180, People of the State of Illinois v. Colwell/General, Inc., by a vote of 6-1. J. Theodore Meyer dissented. (JCM)

An Opinion and Order was adopted in #AS 90-8, Olin Corporation, by a vote of 7-0. (JA)

An Opinion and Order was adopted in #91-146, James Turner, Sr. v. Richard P. Toft, by a vote of 7-0. Board Members J. Anderson, B. Forcade, and J. Theodore Meyer concurred. (RCF)

In R91-24, Exemptions from the Definition of VOM, a Proposal for Public Comment, Proposed Opinion and Order was adopted by a vote of 7-0. (JA)

In R91-30, RACT Amendments: Stage II Vapor Recovery, a Proposed Rule, First Notice, Opinion and Order was adopted by a vote of 7-0. (RCF)

By a vote of 7-0, Agency motion for an extension of time to respond to Petitioner's third motion for sanctions and other relief was granted until March 5, 1992, and because the Board is no longer vested with jurisdiction in the matter and cannot rule upon Petitioner's motion for sanctions and other relief and the Agency's response as a result of Petitioner's appeal of the Board's December 5, 1991 Opinion and Order in #89-184, The Grigoleit Company, with the Fourth District Appellate Court, both motions will be transferred to PCB 92-23, The Grigoleit Company. (JA)

Complainant's motion to supplement the record was denied in #90-59, Michael Christianson, by a vote of 7-0. (MN)

Board Member B. Forcade presented a draft Interim Order in #90-135, The Grigoleit Company. The Interim Order failed by a 1-6 vote with B. Forcade for it and J. Anderson, R.C. Flemal, T. Girard, J.C. Marlin, J. Theodore Meyer and M. Nardulli against it. The case will be reassigned to another Board Member.

Petitioner's motion to withdraw was granted in #91-6, Quantum Chemical Corporation, by a vote of 7-0. (BF)

Petitioner's motion to modify a January 23, 1992 Order was granted with one exception in #91-121, Village of Channahon, by a vote of 6-1. B. Forcade dissented. (JA)

Petitioner's motion for reconsideration of a January 9, 1992 Board Order was denied in #91-138, Kronon Motor Sales, by a vote of 6-1. J. Anderson dissented. (RCF)

Respondent's motion for leave to file an interlocutory appeal was denied in #91-157, The Grigoleit Company, by a vote of 7-0. (JA)

Petitioner's motion to dismiss was granted in #91-166, Cook County Highway Department, by a vote of 7-0. (JCM)

By a vote of 7-0, Petitioner's motion for reconsideration of a January 9, 1992 Board Order was granted, and upon reconsideration, the Board declined to grant the relief requested, Petitioner's motion for leave to file the affidavit of Robert Wallace in support of its motion for reconsideration was denied, and Agency motions for leave to file its response in opposition to Petitioner's motions for reconsideration and for leave to file the affidavit of Robert Wallace instanter were granted in #91-173, Marathon Oil Company. Respondent's request for an extension of time in which to file its response to Complainant's motion for summary judgment was granted until March 2, 1992, in #91-192, Prairie Material Sales, by a vote of 7-0. (JA)

An Order dismissing the proceedings in #91-228, Allsteel, Inc., was adopted by a vote of 7-0. (BF)

An Order directing the Clerk of the Board to publish the required newspaper notice that the parties have requested relief from hearing pursuant to Section 31(a)(2) of the Environmental Protection Act as enacted in Public Act 87-1034 effective August 13, 1991, and advising the parties that the Board will reserve ruling on its request after the statutory 21 day notice has passed, was adopted in #91-254, People of the State of Illinois v. Acme Printing Ink Company, by a vote of 7-0. (JCM)

An Order directing the Clerk of the Board to publish the required newspaper notice that the parties have requested relief from hearing pursuant to Section 31(a)(2) of the Environmental Protection Act as enacted in Public Act 87-1034 effective August 13, 1991, and advising the parties that the Board will reserve ruling on its request after the statutory 21 day notice has passed, was adopted in #91-255, People of the State of Illinois v. Sears, Roebuck and Company, by a vote of 7-0. (JCM)

Petitioner's motion to dismiss was granted in #91-263, Cook County Highway Department, by a vote of 7-0. (BF)

Petitioner's request to consolidate with PCB 91-28, Acme Steel, was granted in #92-2, Acme Steel Company, by a vote of 7-0. (JA)

Petitioner's motion to voluntarily withdraw was granted in #92-7, Danville Gasoline and Oil, by a vote of 7-0. (BF)

Petitioner's motion to file exhibits A, B, and C instanter was granted in #92-18, Village of Glasford, by a vote of 7-0. (JTM)

By a vote of 7-0, Styrene Information and Research Center's motion to admit out-of-state attorney was granted in R90-1(A, B, and C), Toxic Air Contaminants List. (JCM)

By a vote of 7-0, the Board, on its own motion, consolidated dockets R91-20 and R91-21, in the interest of administrative economy. Docket R91-21 was closed and the Board incorporated the material into R91-20, changed the caption and all future filings in the matter should be captioned as follows: R91-20, Potential Infectious Medical Waste (PIMW): Treatment, Storage, and Transfer Facilities and Transportation, Packaging, and Labelling. Flemal, T. Girard, J.C. Marlin, M. Nardulli for it and B. Forcade and J. Theodore Meyer against it. An Order accepting the matter for hearing was then by a vote of 6-1. B. Forcade dissented. (JA)

Minutes of the February 6, 1992 Board Meeting were approved by a vote of 6-0. G. Tanner Girard abstained.


Petitioner's agreed motion for an extension of time in which to file a reply to the Agency's response to its amended petition was
