**MINUTES OF REGULAR BOARD MEETING
SEPTEMBER 17, 1992 CHICAGO, ILLINOIS**

All Board Members were present.

After calling the meeting to order, Chairman Marlin recognized the presence of Bharat Mathur, Chief, Bureau of Air, and Kathleen Bassi, Associate Counsel, Bureau of Air.

An Opinion and Order was adopted in #92-31, City of Roodhouse, by a vote of 6-1. B. Forcade dissented. (JA)

In R90-1(A), Toxic Air Contaminants List, a Supplemental Opinion was adopted by a vote of 7-0. (JCM)

In R92-1, RCRA Update, USEPA Regulations (July 1, 1991 through December 31, 1991), an Adopted Rule, Final Order, Opinion and Order was adopted by a vote of 7-0. (JA)

In R92-7, Recycled Paper, a Proposed Rule, Second Notice, Opinion and Order was adopted by a vote of 7-0. (JTM)

A Default Order was adopted in this Administrative Citation by a vote of 7-0: #92-59, L.P. Fleck, Jr.

An Order denying Respondent's motion to reconsider and vacate a July 30, 1992 Default Order, but granting Respondent an extension of time until November 17, 1992 in which to pay the fine, was adopted in #AC 92-47, Donald Sickles, by a vote of 7-0. (JCM)

Flemal.


