**MINUTES OF REGULAR BOARD MEETING
OCTOBER 1, 1992 CHICAGO, ILLINOIS**

Chairman Marlin called the meeting to order at 10:40 a.m. and announced that the October 15, 1992 regular Board Meeting will be changed to October 16, 1992. All Board Members were present. As Mr. Meyer's arrival was delayed, the meeting commenced with case discussions.

These cases were discussed and ordered held to October 16, 1992 for further discussion or possible decision: ##85-140, Citizens Utilities Company; 90-143, Ohio Grain Company; AS 91-6, Dart Container Corporation; 91-201, RKF Enterprises; AC 92-3, Dennis Grubaugh; 92-10, Kelly Williamson.

An Opinion and Order was adopted in #92-63, Department of the Air Force, by a vote of 7-0. (JTM)

An Opinion and Order was adopted in #92-107, Department of the Army, by a vote of 7-0. (BF)

In R87-37, Public Water Supply, Cross-Connections, a Proposed Rule, First Notice, Opinion and Order was adopted by a vote of 7-0. J. Anderson and B. Forcade concurred. (GTG)

In R90-1(D), Toxic Air Contaminants List, Styrene, a Request for Public Comment, Order was adopted by a vote of 7-0. (JCM)

In R90-23, General Motors Corporation Site-Specific, an Adopted Rule, Final Order, Opinion and Order was adopted by a vote of 7-0. (BF)

Complainant's motion to dismiss was granted in #AC 92-39, Leslie Norman Fred, Sr., by a vote of 7-0. (RCF)

A motion to strike and dismiss, filed by Rochelle Disposal Service, was denied in #AC 92-64, City of Rochelle, by a vote of 7-0. (JCM)

An Order directing the parties to file an updated status report on or before February 1, 1993, was adopted in #AS 91-8, Reynolds Metal Company, by a vote of 7-0. (JCM)

Pursuant to Petitioner's motion for modification of a September 3, 1992 Order, an Order, granting the Agency until December 1, 1992 to submit its response to the petition, was adopted in #AS 91-13, City of Rock Island, by a vote of 7-0. (RCF)

An Order granting the Agency's request for continuance of the October 14, 1992 hearing, requesting the Agency to explain, by October 15, 1992, what "relevant CARB data" it expects to receive,

how the data is relevant to the proceeding and when it expects to receive it, also when the Board can expect to receive all of the technical data; granting the Agency's request that the matter be separated into three dockets (all future filings shall be captioned as follows: #AS 92-4, In the Matter of: Joint Petition of Detroit Diesel Corporation and the Manufacturers Association for Adjusted Standards from 35 Ill. Adm. Code 240.141; the adjusted standard petition of Navistar International Transportation Corporation and the Engine Manufacturers Association shall be assigned to docket #AS 92-11, and shall be captioned as: In the Matter of: Joint Petition of Navistar International Transportation Corporation and the Manufacturers Association for Adjusted Standards from 35 Ill. Adm. Code 240.141; and the adjusted standard petition of Cummins Engine Company and the Engine Manufacturers Association shall be assigned to docket #AS 92-12, and future filings shall be captioned as: In the Matter of: Joint Petition of Cummins Engine Company and the Manufacturers Association for Adjusted Standards from 35 Ill. Adm. Code 240.141; directing all of the Petitioners to file amended petitions and, if applicable, new attachments, in each of the three dockets in accordance with the Board's procedural rules on or before November 13, 1992, or the dockets will be dismissed, and to insure proper notification is given of the redocketing, the Petitioners were directed to publish notice of their amended petitions in accordance with 35 Ill. Adm. Code 106.711, and file their certificate of publication with the Board in accordance with 35 Ill. Adm. Code 106.712, was adopted in #AS 92-4, Detroit Diesel, by a vote of 7-0. (JA)

An Order, directing the parties to file an additional status report to be received by the Board no later than January 15, 1993, was adopted in #89-178, Olin Corporation, by a vote of 7-0. B. Forcade concurred. (GTG)

By a vote of 7-0, the Agency was ordered to file with the Board, no later than October 30, 1992, a stipulation and/or motion for dismissal, a report explaining the status of the case against Respondent Loeb, and a time frame for projected future actions in ##90-89, -91-123, Fred Johnson. (JCM)

Petitioner's motion for leave to voluntarily withdraw the permit appeal and to cancel the hearing was granted in #91-18, Illinois Central Railroad, by a vote of 7-0. (BF)

Petitioner's motion to supplement the record was denied in #91-38, American Waste Processing, by a vote of 7-0. (BF)

Petitioner's motion to voluntarily dismiss was denied, however, in order to save the Board's and parties' resources and time, and in order to protect Petitioner's appeal rights in the event that the Agency fails to issue a corrected permit, the Board granted the Petitioner a 45 day stay in #91-56, Douglas Furniture, by a vote of 6-0. B. Forcade abstained. (JA)

Petitioner's motion to dismiss the permit appeal was granted in #91-57, Monsanto Company, by a vote of 7-0. (BF)

An Order directing the parties to file an additional status report to be received by the Board no later than December 15, 1992, was adopted in #91-122, Condecor, Inc., by a vote of 7-0. (GTG)

An Order directing the Petitioner to file an updated status report on or before November 15, 1992, was adopted in #91-137, Amoco Oil Company, by a vote of 7-0. (JTM)

Agency motion for an extension of time in which to file its response to Petitioner's motion for summary judgment was granted until October 5, 1992 in #92-87, Ramada Hotel, O'Hare, by a vote of 7-0. (JCM)

An Order directing the Clerk of the Board to cause publication of the required newspaper notice that the parties have requested relief from the hearing requirement, was adopted in #92-95, Simplex, Inc., by a vote of 7-0. (JCM)

Petitioner's motion to withdraw counsel was granted and the Agency's motion for leave to file a supplemental answer and affirmative defense was denied as moot in #92-98, Reichhold Chemicals, by a vote of 7-0. (JA)

Petitioner's motion to dismiss was granted in #92-103, City of Freeport, by a vote of 7-0. (MN)
