August 5, 1982 Chicago, Illinois

All Board Members were present.

An Opinion and Order was adopted in #82-42, Glasford, by a vote of 5-0, Mr. Dumelle concurred.

An Opinion and Order was adopted in #82-55, Waste Management v. Tazewell County Board of Supervisors, by a vote of 4-1. Mr. Dumelle dissented.

An Opinion and Order was adopted in #82-63, Citizens Utilities, by a vote of 5-0.

Motion for extension of time to respond to a motion to vacate in #80-125, Welin, was granted by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion for expedited decision in #81-98, Wasteland, was ordered taken with the case.

Motion to dismiss by complainant in #81-115, S.A.J.E., was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to withdraw in #82-41, Algonquin, was granted by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion for reconsideration in #82-69, Hanover Park, was denied by a vote of 5-0. Mrs. Anderson will prepare an Order.

Motion to stay in #82-85, Gilt Edge, was denied by a vote of 5-0. Mr. Anderson will prepare an Order.

An objection having been filed, a hearing was authorized in #82-87, Romeoville, by a vote of 5-0.

In #82-81, Yogi Bear, additional information was requested and a motion for joinder was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

R82-16,-17, Amendments to the New Source Performance Standards were adopted by a vote of 5-0. Mr. Dumelle will prepare the Order.

Minutes as corrected were approved for the Board meetings held July 1, 21 and 26, 1982, by a vote of 5-0.
