MINUTES OF REGULAR BOARD MEETING  
June 28, 1977 Chicago, Illinois

All Board Members were present save Mr. Zeitlin.

Opinions and Orders were adopted by a vote of 4-0 in these cases: ##76-79, City of Chicago; 76-246, Revere Copper, Mr. Dumelle concurred; 76-320, Village of Homewood; 77-6, Chilli-cothe; 77-8, Avenue Bank & Trust; 77-74, CIPS; 77-93, Ohio Power; R77-11, Procedural Rules Amendments, Part VI(A); 75-486, City of Highland; 76-250, Pontiac; 76-274, Union Electric; 77-119, Illinois Power; 77-121, Ronald Carlson; 77-122, Harvey-Ingalls Hospital; 77-132, Sanitary District of Elgin.

An Opinion and Order was adopted in #77-108, City of Chicago by a vote of 3-1, Mr. Dumelle dissented.

Orders were adopted in these cases ordering that hearings be set by a vote of 3-0, Mr. Young abstained: ##75-379, Tri-No Enterprises; 75-330 et al, Monsanto; 75-482, Peabody. Mr. Goodman will prepare the Orders.

Motion for interlocutory appeal was held over by a vote of 4-0 in #76-70, Allaert Rendering. Mr. Young will prepare the Order.

Motion for modification in #76-239, Del Monte was denied by a vote of 4-0. Mr. Goodman will prepare an Order.

Motion to set aside order in #76-292, Janson was denied by a vote of 4-0. Dr. Satchell will prepare an Order.

Motion for additional time in #76-299, Wheaton was granted by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motion to amend in #76-316, South DuPage was granted by a vote of 4-0. Mr. Dumelle will prepare the Order.

Motion to dismiss in #76-322, Navajo Freight was granted by a vote of 4-0. Mr. Young will prepare an Order.

Motion to amend in #77-24, Peabody was granted by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motion to file an answer in #77-60, Commans was granted by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motion to dismiss was denied and motion to amend was granted in #77-133, Will County Produce by a vote of 4-0. Mr. Young will prepare an Order.

An Order was adopted in #77-136, Sauget regarding motion to dismiss and motion to continue by a vote of 4-0. Mr. Goodman will prepare the Order.

A motion on R75-6, Total Dissolved Solids was denied by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motion for hearing was granted and ordered set in #77-7, City of Hurst by a vote of 4-0. Mr. Young will prepare the Order.

Motion for extension of time in #77-144, American Can was granted by a vote of 4-0. Mr. Dumelle will prepare an Order.
