MINUTES OF REGULAR BOARD MEETING JUNE 19, 1997 CHICAGO, ILLINOIS - 10:30 A.M.

After calling the meeting to order, Board Member R.C. Flemal welcomed members of the public and staff to the meeting. Thereafter, the Clerk was asked for a roll call, and all Board Members answered present except for Chairman Claire Manning who was absent.

Minutes of the June 5, 1997 Board Meeting were approved by a vote of 6-0.

Board Member Kathleen Hennessey then introduced and welcomed her new secretary, Frances Sanchez, and Board Member M. McFawn introduced and welcomed her new assistant, Charles King.

In R97-25, Conforming Amendments for the Great Lakes Initiative: 35 Ill. Adm. Code Part 302.101, 302.105, 302.Subpart E, 303.443, and 304.222, a Proposed Rule, First Notice, Opinion and Order was adopted by a vote of 5-0. Board Member K.M. Hennessey abstained.
(GTG)(CAM)(JY)

An Order accepting the proposal for hearing, was adopted in R97-29, Amendments to Location Standards for Landscape Waste Compost Facilities, 35 Ill. Adm. Code 830.203(c), by a vote of 6-0. **(KMH)**

An Order accepting the proposal for hearing, and then staying the hearings on the proposal for 120 days until the Part 186 rules are finalized, was adopted in R97-30, Amendments to 35 Ill. Adm. Code Part 611 (Cross Reference to Lab Accreditation Rules at 35 Ill. Adm. Code 186), by a vote of 5-0. Board Member K.M. Hennessey abstained. **(JTM)**

An Order granting the Agency's request to delete from the caption of prior and future documents in reference to the "15% ROP Plan", rescinding a June 5, 1997 order which accepted the instant proposal as a 15% ROP proposal under the fast-track rulemaking provisions of Section 28.5 of the Illinois Environmental Protection Act (Act), and accepting the matter for hearing pursuant to Section 27 of the Act, was adopted in R97-31, Wood Furniture Coating: Amendments to 35 Ill. Adm. Code 211, 218, and 219, Subpart F, by a vote of 6-0. **(RCF)**

An Order granting the Agency's motion for an extension of time until June 27, 1997 to respond to the substantive issues raised by the petitioner's amended requested relief, was adopted in #AS 94-20, Petition of the Galesburg Sanitary District for an Adjusted Standard from 35 Ill. Adm. Code 304.105 (Ammonia Nitrogen), by a vote of 5-0. Board Member K.M. Hennessey abstained. **(JY)**

An Opinion and Order was adopted in #AS 97-4, Petition of Ensign-Bickford Company for an Adjusted Standard from 35 Ill. Adm. Code 703.183, by a vote of 5-1. Board Member J. Theodore Meyer dissented. **(GTG)**

An Opinion and Order granting the joint motion requesting relief from the Illinois Environmental Protection Act's hearing requirement, and accepting the Stipulation and Settlement Agreement in the amount of \$35,000, was adopted in #96-220, People of the State of Illinois v. AlliedSignal, Inc., by a vote of 5-0. Board Member K.M. Hennessey abstained. **(RCF)**

An Opinion and Order granting the joint motion requesting relief from the Illinois Environmental Protection Act's hearing requirement, accepting the Stipulation and Settlement Agreement in the amount of \$5,000.00 as to respondent Hellman Trucking Company (Hellman) only, noting that acceptance of the stipulation and settlement agreement moots all pending motions before the Board concerning the complainant and respondent Hellman, directing that the caption in future orders reflect that the Board has accepted the settlement agreement between the complainant and respondent Hellman, dismissing Hellman as a respondent in the matter, and that the matter will proceed against the remaining respondents, was adopted in #97-38, People of the State of Illinois v. Amsted Industries, Inc. d/b/a Griffin Wheel Company, L.E. Swiderski d/b/a Griffin Wheel Company, Horsehead Resource Development Company, Inc., and Hellman Trucking Company, Inc., by a vote of 6-0. **(JY)**

An Opinion and Order granting the joint motion requesting relief from the Illinois Environmental Protection Act's hearing requirement, accepting the Stipulation and Settlement Agreement in the amount of \$25,000.00, was adopted in #97-93, People of the State of Illinois v. Ashland, Inc., by a vote of 6-0. **(GTG)**

An Opinion and Order granting the joint motion requesting relief from the Illinois Environmental Protection Act's hearing requirement, accepting the Stipulation and Settlement Agreement in the amount of \$3,000.00, was adopted in #97-95, People of the State of Illinois v. City of Sterling, by a vote of 6-0. **(RCF)**

An Opinion and Order was adopted in #97-139, Residents Against A Polluted Environment and The Edmund B. Thornton Foundation v. County of LaSalle and LandComp Corporation, by a vote of 6-0. **(McF)**

A Default Order finding that the respondent violated Sections 21(p)(1), 21(p)(3), and 21(p)(4) of the Illinois Environmental Protection Act, and assessing a \$1,500.00 penalty, was adopted in #AC 97-61, IEPA v. William Decker, by a vote of 6-0. **(RCF)**

A Default Order finding that the respondent violated Sections 21(p)(1) and 21(p)(3) of the Illinois Environmental Protection Act, and assessing a \$1,000.00 penalty, was adopted in #AC 97-62, County of Will v. Crown-Trygg, Corporation, by a vote of 6-0. **(RCF)**

An Order granting the complainant's motion to withdraw the administrative citation, and closing the docket, was adopted in #AC 97-65, IEPA v. Peter Gomez and Teri Wakeland, by a vote of

6-0. (RCF)



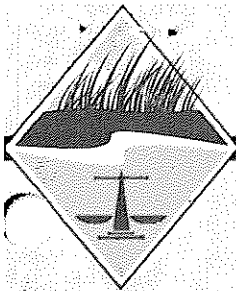

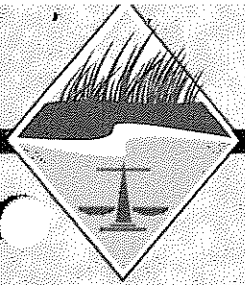
