#### **PUBLIC NOTICE**

Notice of Petition by ExxonMobil Oil Corporation for an Adjusted Standard before the Illinois Pollution Control Board, On April 25, 2025, ExxonMobil: filed a petition with the Illinois Pollution Control Board (docker no. AS 2025-001) for an adjusted standard from 35 III. Adm. Code 721.131 and 35 III. Adm. Code 721.132 for its refinery located at 25915 S. Frontage Road, Channahon, Illinois. The refinery produces gasoline, diesel, and other key feedstocks, employs approximately 625 personnel, and supports an average of about 250 contractors. ExxonMobil's proposed adjusted standard requests the delisting of specific "Primary Treatment Solids" ("PTS") generated at the refinery and currently designated as F037, F038, K048, and K051 hazardous wastes.

The PTS wastes are generated from the refinery's wastewater treatment and oil recovery processes and are currently managed as hazardous wastes under applicable Illinois and federal RCRA regulations, based on their current designations. The technical support document filed with the petition provides data and information demonstrating that the PTS wastes do not meet the criteria for hazardous waste classification. The proposed adjusted standard would allow the delisted PTS to be managed as non-hazardous woste, subject to rigorous testing and reporting

procedures.

Any person may cause a public hearing to be held in the above-described adjusted standard proceeding by filing a hearing request with the Board within 21 days after the date of the publication of this notice. The hearing request should indicate the docket number for the adjusted standard proceeding, as found in this notice. The hearing request must be mailed to the Clerk, Illinois Pollution Control Board, 100 W. Randolph Street, Sulte 11-500, Chicago, Illinois 60601, or filed electronically through COOL, local-
