HEARING OFFICER ORDER

As set forth below, this order establishes a pre-first notice deadline for filing public comments with the Board. By way of background, on January 22, 2004, the Board accepted the rulemaking proposal of the Illinois Environmental Protection Agency (Agency) in R04-20. The Agency proposes to amend the Board's air pollution rules at 35 Ill. Adm. Code 211, 218, 219. For purposes of hearing, the Board consolidated the R04-20 rulemaking with R04-12, a Board-initiated rulemaking proposal to amend the Board's air pollution rules at 35 Ill. Adm. Code 214.

For this consolidated rulemaking, the Board held a hearing in Chicago on March 18, 2004, and in Springfield on May 6, 2004. The transcripts of those hearings are available on the Board's Web Site through the Clerk's Office On-Line (COOL) at www.ipcb.state.il.us. Two hearing exhibits were entered into the record:

June 18, 2004, is the deadline for filing written public comments with the Clerk's Office before the Board proceeds to first notice in R04-12 and R04-20. Public comments must be filed at the following address:

Each filing should identify the docket "R04-12/R04-20" and specify whether the comment relates the Agency's proposal in R04-20 or the Board's proposal in R04-12. There will be other opportunities to file public comments in this consolidated rulemaking, but filing by June 18, 2004, ensures that your comment will be considered by the Board before the Board adopts proposed rules for first-notice publication in the *Illinois Register*.
