**MOTION FOR EXTENSION TO SUBMIT PUBLIC COMMENTS**

The United States Environmental Protection Agency, Region 5 (U.S. EPA) respectfully requests leave to file this motion for an extension of the 45-day public comment period on the consolidated state Identical-in-Substance rulemakings (R25-1, R25-9) in this matter.

The Illinois Pollution Control Board (Board) anticipates accepting public comments on the above rulemakings from interested persons for a period of 45 days from the projected October 24, 2025 publication date of the Illinois register notice, pursuant to 415 ILCS 5/7.2 and 5/17/5 (2020). Based on the projected publication date, the projected due date for public comments is December 8, 2025. The Board proposes to amend various state drinking water regulations set forth in 35 Ill. Adm. Code 611. The Board rulemakings were necessitated by revisions to, or the adoption of, National Primary Drinking Water Regulations (“NPDWRs”) promulgated by the U.S. EPA under authority of the federal Safe Drinking Water Act (“SDWA”), 42 U.S.C. §§ 300f et seq.

Staff from U.S. EPA, Region 5 intend to submit public comments on this matter. However, given the on-going federal government shutdown initiated on October 1, 2025, the expected and imminent depletion of carryover funding from U.S. EPA’s previous fiscal year which as of the date of this motion has allowed U.S. EPA staff to operate, and the uncertainty of the shutdown’s duration, U.S. EPA staff may not be in operation to develop public comments in a timely manner. In light of the volume, complexity, and importance of the subject matter of the rulemakings, U.S. EPA requests an extension of an additional 45 days, until January 22, 2026, to file its public comments. This should allow adequate time for U.S. EPA staff to raise potential stringency concerns, in furtherance of the state primary enforcement authority

delegation process under Section 1413 of SDWA, 42 U.S.C. § 300g-2, and federal regulations promulgated thereunder (40 C.F.R. §§ 142.10, 142.12).
