SUPPLEMENTAL TESTIMONY OF RORY DAVIS

On September 18, 2025, I appeared and testified on behalf of the Illinois EPA at the first hearing on the proposed aerospace coating rule revisions in the above-captioned proceeding (R25-25). In responding to the Illinois Pollution Control Board’s (“Board”) pre-filed question 5B, the Agency stated it was “considering whether additional record-keeping provisions are needed for the low-volume coatings. If so, the Agency will propose additional language as soon as possible.” See, R25-25, *First Hearing Transcript* (September 18, 2025) at 13:1-4.

Following further review of the current regulations under 35 Ill. Adm. Code 219.204 and 219.211, the Agency concluded that the current record-keeping provisions are sufficient, and so the Agency will not be proposing any additional language. Section 219.211(j)(1) provides that owners or operators using coatings listed in Section 219.204(r) must maintain a current list of coatings in use with their category and VOM content as applied and record their coating usage on an annual basis. Primers, topcoats, chemical milling maskants, and specialty coatings are coatings listed in Section 219.204(r). Any usage of separate formulations of primers, topcoats, chemical milling maskants, and specialty coatings with VOM content higher than the coating limitations in Section 219.204(r) will be recorded separately and be identifiable by the Agency. Therefore, the Agency does not believe any additional record-keeping provisions are required or necessary.
