NOTICE OF REINSTATEMENT OF DECISION DEADLINE

NOW COMES Petitioner Waste Management of Illinois, Inc., by its attorneys, Taft, Stettinius & Hollister LLP, and hereby withdraws its open waiver and reinstates the 120-day decision deadline in this matter.

1. Waste Management of Illinois, Inc. filed a petition for review of Illinois EPA's denial of its permit application on July 23, 2024.
2. The parties filed cross motions for summary judgment on March 27, 2025.
3. The motions for summary judgment have been fully briefed since May 1, 2025.
4. Waste Management of Illinois, Inc. filed an open waiver of the decision deadline on May 15, 2025.
5. Pursuant to 35 Ill. Admin Code 101.308, Waste Management of Illinois, Inc. hereby provides notice that it is electing to reinstate the 120-day decision period.
6. 35 Ill. Admin Code 101.308(c)(1) provides that if the decision deadline is reinstated, "the decision period restarts on the date on which the notice to reinstate is filed with the Board." Accordingly, the decision deadline for this matter is now April 15, 2026.
