
HEARING OFFICER ORDER

On January 29, 2026, all parties participated in a telephonic status conference with the hearing officer. Petitioner stated that it will file an additional waiver of the statutory decision deadline to April 16, 2026.

It was suggested by me that a telephonic status conference be scheduled for February 5, 2026. At that time, discussions will center on the hearing dates, hearing location, and the number of witnesses should the Board not decide the pending cross-motions for summary judgement.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on February 5, 2026, at 1:00 p.m. The telephonic status conference must be initiated by the petitioner, and provide a call-in number, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter, witnesses who will be testifying, should a hearing be necessary, and number of days necessary to complete the hearing.

IT IS SO ORDERED.




