MOTION FOR EXTENSION OF TIME

The Illinois Environmental Protection Agency (“Illinois EPA” or “Agency”), by and through its attorney, hereby submits its Motion for Extension of Time and requests a 60-day extension of time, up to and including April 14, 2026 to file its Recommendation concerning Goodall Tire Co., Inc.’s request for an Adjusted Standard from 35 Ill. Adm. Code Part 848 stating as follows:

1. On December 31, 2025, Goodall Tire Co., Inc. (“Petitioner”) filed its Petition for an Adjusted Standard from Sections 848.202(a)(1)(B)-(C), 848.202(c)(2), 848.303, and 848.304 and Finding of Inapplicability of Part 848.

2. The Agency’s recommendation must be filed with the Board within 45 days after the filing of the petition, *i.e.*, by February 14, 2026. 35 Ill. Admin. Code. 104.416 Agency Recommendation and Petitioner Response.

3. The Agency has conducted a review of this petition and has initiated discussions with the Petitioner regarding additional information needed, however the Agency will need additional time to review and develop recommendations based upon those ongoing discussions.

4. Based on the Agency’s review, the number of requests contained within the Petition, and discussions with the Petitioner, the Agency requests the Board extend the deadline to

file its recommendations concerning the Petition of Goodall Tire Co., Inc. for Adjusted Standards from Sections 848.202(a)(1)(B)-(C), 848.202(c)(2), 848.303, and 848.304.

5. Counsel for the Agency contacted counsel for Goodall Tire Co. Inc., who indicated they have no objection to the requested extension of time.

WHEREFORE, the Agency requests the Illinois Pollution Control Board grant its Motion for Extension of Time and grant the Agency an additional 60 days, up to and including April 15, 2026, to file its recommendation with the Board.
