STIPULATION OF SETTLEMENT AND DISMISSAL OF RESPONDENTS' PETITION FOR ADMINISTRATIVE REVIEW

NOW COMES the Complainant, ILLINOIS ENVIRONMENTAL PROTECTION AGENCY ("Illinois EPA"), by and through its attorney, Michelle M. Ryan, and the Respondents, CITY OF SALEM, ROGER KINNEY, DICK BROWN and JASON BRUCE, ("Respondents"), by and through their attorney, Christine G. Zeman, HODGE DWYER ZEMAN and pursuant to Sections 31.1 and 42(b)(4-5) of the Illinois Environmental Protection Act ("Act"), 415 ILCS 5/31.1 and 42(b)(4-5) (2002), and Section 103.180 of the Illinois Pollution Control Board's ("Board") Rules and Regulations, 35 Ill. Adm. Code 103.180, the parties hereby enter into this STIPULATION OF SETTLEMENT AND DISMISSAL OF RESPONDENT'S PETITION FOR ADMINISTRATIVE REVIEW ("Agreement"), and in support hereof, the parties respectfully state as follows:

1. On April 22, 2004, John Senjan, an Environmental Protection Specialist for the Illinois EPA's BOL-Collinsville Regional Office, conducted an inspection of a facility owned and

operated by the Respondent. The facility is located at 900 East Lake Street, Salem, Marion County, Illinois, and is designated with Illinois EPA Site Code No. 1218130007.

- 2. On or about June 4, 2004, the Illinois EPA served the Respondents with Administrative Citation No. 275-04-AC, alleging therein that the Respondents had conducted a sanitary landfill operation in a manner which resulted in the following occurrences: (1) uncovered refuse, a violation of 415 ILCS 5/21(o)(5) (2002); and (2) failure to collect and contain litter, a violation of 415 ILCS 5/21(o)(12).
- 3. On or about July 6, 2004, the Respondents filed a Petition for Review contesting the administrative citation.
- 4. In an effort to resolve this matter without the need for a hearing, the parties have engaged in settlement negotiations and have reached this Agreement and hereby tender it to the Board for approval, the terms and conditions of which are as follows:
 - a. Respondents do not admit that they conducted a sanitary landfill operation resulting in exposed refuse, a violation of 415 ILCS 5/21(o)(5) (2002). Nevertheless, in the interest of settlement, Respondents agree to pay a civil penalty of \$500.00 pursuant to 415 ILCS 5/42(b)(4) (2002).
 - b. Respondent agrees to pay the statutory civil penalty within 30 days of the date of the Board Order accepting this agreement.
 - c. Respondent agrees to diligently comply with, and shall cease and desist from further violation of the Act, 415 ILCS 5/1 et seq. (2002), and the Board's rules and regulations, 35 Ill. Adm. Code Subtitles A through H.

- d. The Illinois EPA agrees not to refer the violations that are the subject of this administrative citation to the Office of the Illinois Attorney General or any other prosecuting authority for the initiation of a criminal or civil enforcement action.
- e. Respondent's Petition for Review filed with the Board on or about July 6, 2004, shall be dismissed.

WHEREFORE, the parties request that the Board accept this Agreement and issue an order consistent with its terms and conditions.
