# MOTION TO DISMISS ADMINISTRATIVE CITATION

NOW COMES the Complainant, the Illinois Environmental Protection Agency ("Illinois EPA"), by and through its attorney, Special Assistant Attorney General James M. Kropid, pursuant to 35 Ill. Adm. Code 108.402, and respectfully states as follows:

- (1) On January 26, 2005, the Illinois EPA issued an Administrative Citation to Respondent, Landers' Children Family, LLC, based on an inspection conducted on December 1, 2004.
- (2) On January 27, 2005, Steve Townsend, Illinois EPA Inspector tried to hand-deliver the Administrative Citation for personal service on Respondent, Landers' Children Family, LLC. Service was unsuccessful.
- (3) On February 15, 2005, the Administrative Citation that was mailed to Respondent by Certified Mail, was sent back to the Illinois EPA from the United States Postal Service, as unclaimed.

(4) Because Landers' Children Family, LLC was not timely served within 60 days as required by 415 ILCS 5/31.1(b), this Administrative Citation against Respondent, Landers' Children Family, LLC should be dismissed.
