NOTICE OF HEARING

Public Notice is hereby given that the Pollution Control Board will hold a public hearing in the matter of Petition of Citgo Petroleum Corporation for an Adjusted Standard from 35 Ill. Adm. Code 216.121, AS 26-1. This hearing is regarding the adjusted standard to 35 Ill. Adm. Code 216.121, requested by CITGO Petroleum Corporation ("Citgo") and under consideration by the Board in AS26-1. If adopted by the Board, the Illinois Environmental Protection Agency ("Illinois EPA") will submit the proposed adjusted standard to 35 Ill. Adm. Code Part 216 to the United States Environmental Protection Agency ("USEPA") for review and approval as a revision to Illinois' carbon monoxide State Implementation Plan ("SIP"). The requested adjusted standard establishes alternative emission limitations applicable during periods of startup, shutdown, or malfunction for seven emission units equipped with continuous emission monitoring systems, with actual heat input greater than 10 MMBtu/hr, at Citgo's Lemont refinery. The revisions submitted to USEPA will include an analysis demonstrating that the proposal does not interfere with attainment or maintenance of any applicable National Ambient Air Quality Standard, reasonable further progress, or any other applicable requirement of the Clean Air Act ("CAA"). This notice is intended to satisfy the requirements of Section 110(l) of the CAA regarding public notice for SIP submittals, 42 USC §7410(l). The Public Hearing will be held June 26, 2026, beginning at 11:00 a.m., at the Lemont Township Community Center, Boardroom, 16300 Alba St. Lemont, IL 60439. The hearing is subject to cancellation without notice and may be confirmed by calling the Office of the Clerk at 312/814-3461.
