<u>PCB 24-50</u>	<u>Chronister Oil Co. d/b/a Qik-N-EZ v. Illinois Environmental Protection Agency</u> (UST Appeal) – The Board directed the parties and hearing officer to proceed in accordance with the Fourth District Appellate Court’s reversal and remand of April 7, 2026.	4-0 roll call vote
<u>PCB 26-49</u>	<u>People of the State of Illinois v. Savanna Quarry, Inc.</u> (Air, CAAPP; Water, NPDES – Enforcement) – In this enforcement action concerning Savanna Quarry’s Carroll County operation of limestone quarrying and processing and asphalt batch mixing, the Board granted relief from the hearing requirement of Section 31(c)(1) of the Environmental Protection Act (415 ILCS 5/31(c)(1) (2024)), accepted a stipulation and proposed settlement, and ordered Savanna Quarry to pay a \$27,000 civil penalty and to cease and desist from further violations.	4-0 roll call vote
<u>PCB 26-58</u>	<u>Phillips 66 Company v. Illinois Environmental Protection Agency</u> (Air – Variance) – The Board accepted Phillips 66’s petition for variance from compliance dates for nitrogen oxides (NO _x) emissions limitations concerning two process heaters at the Wood River Refinery in Madison County.	4-0 roll call vote
<u>PCB 26-59</u>	<u>People of the State of Illinois v. Keshav Investments, LLC d/b/a CD One Price Cleaners #9</u> (Air – Enforcement) – The Board accepted for hearing the People’s complaint concerning Keshav Investments’ drycleaning facility in Cook County.	4-0 roll call vote

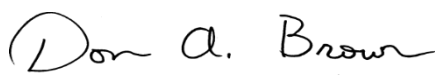
