RECOMMENDATION

Now Comes the Illinois Environmental Protection Agency ("Illinois EPA") by James Allen Day, one of its attorneys, and pursuant to Section 125.204 of the Illinois Pollution Control Board's (Board) regulations files the following Recommendation regarding the tax certification of water pollution control facilities pursuant to 35 Ill. Adm. Code 125.204.

- On December 31, 2002, the Illinois EPA received a request from Holland Energy, LLC-Beecher City for an Illinois EPA recommendation regarding the tax certification of water pollution control facilities pursuant to 35 Ill. Adm. Code 125.204, and noted the request as log number TC-39-02. (Exhibit A)
- 2) The applicant's address is: Holland Energy, LLC
 Rural Route 3, Box 270A
 Beecher City, Illinois 62414-0065
- The water pollution control facilities in this request are located at Section 16, Township 9

 North, Range 4 East of the 3rd Principal Meridian in Shelby County, Illinois at the above street address and consist of the following:

The Sanitary Sewer Collection and Treatment System, consisting of various sets of piping, two lift stations with grinder pumps, a septic system and leach field for

the collection and treatment of sanitary wastewaters at the facility. (These facilities are further described in Exhibit A)

- Section 11-10 of the Property Tax Code, 35 ILCS 200/11-10 (2000), defines "pollution control facilities" as: "any system, method, construction, device or appliance appurtenant thereto or any portion of any building or equipment, that is designed, constructed, installed or operated for the primary purpose of: (a) eliminating, preventing, or reducing air or water pollution ...or (b) treating, pretreating, modifying or disposing of any potential solid, liquid or gaseous pollutant which if released without treatment, pretreatment modification or disposal might be harmful, detrimental or offensive to human, plant or animal life, or to property."
- Section 11-10 of the Property Tax Code, 35 ILCS 200/11-10 (2000), provides that:

 "Pollution control facilities' shall not include, however, ...(3) any facility operated by any person other than a unit of government, whether within or outside of the territorial boundaries of a unit of local government, for sewage disposal or treatment..."
- 6) Pollution control facilities are entitled to preferential tax treatment, 35 ILCS 200/11-5 (2000).
- Based on the information in the application and the purpose of the facilities (sewage disposal or treatment), it is the Illinois EPA's engineering judgment that the described facilities are not "pollution control facilities," pursuant to 35 Ill. Adm. Code 125.200(a), with the primary purpose of eliminating, preventing, or reducing water pollution, or as

otherwise provided in 35 Ill. Adm. Code 125.200. Therefore, the facilities are not eligible for tax certification from the Board.

8) Therefore, the Illinois EPA recommends that the Board deny the requested tax certification.
