ORDER OF THE BOARD:

This matter comes before the Board upon the April 25, 1996 filing of an administrative citation pursuant to Section 31.1 of the Environmental Protection Act (Act) by the Illinois Environmental Protection Agency (Agency). A copy of that administrative citation is attached hereto, but will not be printed in the Board's opinion volumes. Service of the administrative citation was made upon James Deisher (Deisher) on April 15, 1996. The Agency alleges that on February 26, 1996, Deisher, present owner and/or operator of a facility located in Lawrence County and commonly known to the Agency as St. Francisville/Deisher, violated Sections 21(p)(1), 21(p)(2), and 21(p)(3) of the Act. The statutory penalty established for each violation is \$500.00 pursuant to Section 42(b)(4) of the Act.

Deisher has not filed a petition for review with the Clerk of the Board within 35 days of the date of service as allowed by Section 31.1(d)(2) of the Act. Therefore, pursuant to Section 31.1(d)(1), the Board finds Deisher has violated the provisions alleged in the administrative citation. Since there are three (3) such violations, the total penalty to be imposed is set at \$1,500.00.

1. It is hereby ordered that, unless the penalty has already been paid, within 30 days of the date of this order, Deisher shall, by certified check or money order payable to the Illinois Environmental Protection Trust Fund, pay a penalty in the amount of \$1,500.00, which is to be sent to:

2. Respondents shall include the remittance form and write the case name and number and their social security or federal employer identification number on the certified check or money order.

3. Penalties unpaid after the due date shall accrue interest pursuant to Section 42(g) of the Act.
4. Payment of this penalty does not prevent future prosecution if the violation continues.

IT IS SO ORDERED.

Section 41 of the Environmental Protection Act (415 ILCS 5/41 (1994)) provides for the appeal of final Board orders within 35 days of the date of service of this order. The Rules of the Supreme Court of Illinois establish filing requirements. (See also 35 Ill. Adm. Code 101.246 "Motions for Reconsideration.")
