June 26, 2002) and ordered respondents to pay a civil penalty of \$3,000. Robert Peters – In response to a joint stipulation and settlement agreement in this administrative citation action involving an Adams County facility, the Board found respondent violated Section 21(p)(1) Environmental Protection Act (Act) (415 ILCS 5/21(p)(1) (2000), *amended by* P.A. 92-0574, eff. June 26, 2002) and ordered respondent to pay a civil penalty of \$1,500. The Board also granted the parties’ joint motion to dismiss the alleged violation of Section 21(p)(5) of the Act (415 ILCS 5/21(p)(5) (2000), *amended by* P.A. 92-0574, eff. June 26, 2002).

**PCB 03-17**      People of the State of Illinois v. Petroleum Fuel & Terminal Company – In this air enforcement action concerning a Madison County facility, the Board granted relief from the hearing requirement of Section 31(c)(1) of the Environmental Protection Act (415 ILCS 5/31(c)(1) (2000), *amended by* P.A. 92-0574, eff. June 26, 2002), accepted a final stipulation and settlement agreement, and ordered the respondent to pay a total civil penalty of \$22,000, and to cease and desist from further violations. Respondent agreed to perform by December 31, 2003, a Supplemental Environmental Project or payment of an additional \$28,000 in penalties, if it fails to do so.

**PCB 03-23**      People of the State of Illinois v. City of Des Plaines and McDonough Associates, Inc. – In this public water supply enforcement action concerning a Cook County facility, the Board granted relief from the hearing requirement of Section 31(c)(1) of the Environmental Protection Act (415 ILCS 5/31(c)(1) (2000) *amended by* P.A. 92-0574, eff. June 26, 2002), accepted a final stipulation and settlement agreement, and ordered the respondents to pay a total civil penalty of \$26,000, and to cease and desist from further violations.
