## CHAIR'S UPDATE

In this issue of the *Environmental Register*, I write to both welcome the newest Board Member and commemorate the passing of a former Board Member.

I am delighted to announce that Governor JB Pritzker appointed Michelle Gibson to the Board in November 2021. Board Member Gibson brings a wealth of relevant experience to the Board. She is a Registered Environmental Health Specialist who has spent more than 15 years in environmental consulting, waste diversion, resource management, and environmental public health. I warmly welcome her on behalf of everyone at the Board.

Sadly, last November, former Board Member Gary Blankenship died at age 75. He served on the Board from 2008 to 2011. I did not have the pleasure of working with Member Blankenship but all who did fondly remember him for his practical insights into complex issues, his kind smile, and his readiness to help in any situation. Board proceedings he successfully led include rulemakings to improve our State's regulations on financial assurance for landfill cleanups and controls for nitrogen oxides emissions.

Mr. Blankenship was a U.S. Army veteran, serving in Vietnam from 1966-1967. He became an apprentice in the Plumbers & Pipefitters Local 422 in 1971 and a Journeyman Pipefitter in 1976. He was elected Local 422's Business Manager in 1981 and served in that capacity until joining the Board. From this background, Mr. Blankenship came to the Board with experience in constructing and maintaining pollution control systems at a wide variety of facilities, including coal-fired power plants, wastewater treatment plants, refineries, chemical plants, incinerators, and landfills.



We are very grateful for Mr. Blankenship's many contributions to protecting Illinois' environment and send our deepest sympathies to his family.

## **RULEMAKING UPDATE**

#### **Board Proposes Non-Substantive Amendments to Water Pollution Rules**

On November 4, 2021, the Board issued an order proposing, for public comment, non-substantive amendments to Illinois' water pollution rules. These rules include water quality standards, water use designations, effluent standards, and provisions for monitoring, reporting, and permitting. The proposed amendments are part of a larger undertaking by the Board to update its rules across multiple media and subject areas. The proposal will remove unnecessary language, replace outdated language, update statutory references, and reorganize provisions for clarity. The amendments include proposed changes from the Illinois Environmental Protection Agency to delete outdated provisions, appropriately match incorporations by reference, eliminate redundancies, and correct citations.

In its order, the Board welcomed public comment on all aspects of the proposal and specifically requested public comment on 41 enumerated items. The rulemaking is captioned <u>Amendments to 35 Ill. #### Board to Hold Public Hearings on Groundwater Quality Rulemaking Proposal

On December 7, 2021, the Illinois Environmental Protection Agency (IEPA) filed a rulemaking proposal to update the Board's groundwater quality regulations. IEPA seeks to uphold the policy of the Illinois Groundwater Protection Act "to restore, protect, and enhance the groundwaters of the State, as a natural and public resource." 415 ILCS 55/2(b). Specifically, IEPA states that its proposed rule changes are designed to keep Illinois' standards "current as scientific data and methods supporting the development of groundwater quality standards have evolved." Among other amendments, IEPA proposes location-specific Class III groundwater quality standards for six dedicated nature preserves, as well as groundwater quality standards for six Per- and Polyfluoroalkyl Substances or "PFAS."

By order of January 6, 2022, the Board accepted the proposal for hearing. Currently, the Board has two public hearings scheduled. The first hearing is set for March 9, 2022, and the second for April 4, 2022. Both hearings will be held by videoconference between Springfield and Chicago. Details are in the hearing officer's <u>notice and order</u> of January 13, 2022.

## TIME-LIMITED WQS UPDATE

#### Board Adopts Illinois' First "Time-Limited Water Quality Standard"

On November 4, 2021, the Board issued an order adopting the first "time-limited water quality standard" (TLWQS) in Illinois. A TLWQS is a form of temporary relief from a water quality standard. The Board's TLWQS authority was added to the Illinois Environmental Protection Act by Public Act 99-937, effective February 24, 2017. In turn, the Board adopted procedural rules—effective April 27, 2018—for conducting TLWQS proceedings. The Board may issue a TLWQS for a single discharger, multiple dischargers, a watershed, a water body, or a waterbody segment.

In this proceeding, the Board issued a 15-year, watershed TLWQS for chloride to 48 petitioners that discharge into the Lower Des Plaines River (LDPR) watershed and portions of the Chicago Area Waterway System (CAWS) watershed. These watersheds do not meet the current chloride water quality standard during the winter due largely to the necessary use of sodium chloride—also known as "road salt"—for public safety, *i.e.*, keeping sidewalks, streets, and highways free of snow and ice. If dischargers other than the 48 petitioners satisfy the criteria in the Board's order, they may be granted coverage under the TLWQS by the Illinois Environmental Protection Agency (IEPA).

This TLWQS specifies the highest attainable condition (HAC) of the watersheds during the term of the relief. Dischargers subject to the TLWQS must achieve the HAC by complying with the order's requirements, which include:

- Participating in chloride workgroups corresponding to the LDPR or CAWS watershed.
- Implementing best management practices (BMPs) to reduce chloride discharges.
- Submitting annual reports on BMP efficacy to IEPA and making them publicly available.
- Filing with the Board proposed re-evaluations at five-year intervals assessing the HAC.

Before adopting the TLWQS, the Board held a public hearing and reviewed petitioners' demonstrations and IEPA's recommendation, as well as public comments from numerous participants, including the United States Environmental Protection Agency (USEPA). The TLWQS will take effect for federal Clean Water Act purposes after approval by USEPA. The ultimate objective remains compliance with the underlying chloride water quality standard, which remains applicable to dischargers not covered by the TLWQS.

This TLWQS proceeding is captioned <u>Village of Homewood et al. v. Illinois Environmental</u> <u>Protection Agency</u>, PCB 16-14 et al. (consol.). #### Board Grants "Time-Limited Water Quality Standard" to MWRD for Dissolved Oxygen

On December 16, 2021, the Board issued an order granting a "time-limited water quality standard" (TLWQS) to the Metropolitan Water Reclamation District of Greater Chicago (MWRD). A TLWQS is a form of temporary relief from a Board water quality standard. MWRD sought a dissolved oxygen TLWQS to account for discharges into the Chicago Area Waterways System (CAWS) from combined sewer overflow (CSO) outfalls. These CSO outfalls are associated with MWRD's O'Brien, Calumet, and Stickney water reclamation plants. The TLWQS has a five-year term.

A combined sewer system carries stormwater and wastewater to MWRD's reclamation plants. However, when heavy rainfalls occur, excess stormwater can overwhelm the capacities of the collection systems and reclamation plants, resulting in discharges from CSO outfalls. These outfalls provide relief from local flooding, but they do so by allowing untreated excess flow from the combined sewer system to be discharged directly into the CAWS. CSO discharges contribute to non-compliance with the Board's dissolved oxygen water quality standards by lowering dissolved oxygen levels in the CAWS. Portions of the CAWS currently do not meet the dissolved oxygen water quality standards due to CSO discharges. Sufficient levels of dissolved oxygen are necessary for aquatic plant and animal life.

The TLWQS issued by the Board specifies the "highest attainable condition" (HAC) of the designated receiving segments of the CAWS during the term of the relief. The HAC includes requirements related to MWRD's multi-decade construction project, the Tunnel and Reservoir Plan (TARP). The goal of TARP is to eliminate CSO discharges into the CAWS by constructing large reservoirs that capture untreated excess flow and store it until the reclamation plants can begin treatment. TARP is expected to be completed in 2029. To improve dissolved oxygen levels in the meantime, the HAC includes specified interim pollution minimization measures, among other requirements.

Before adopting the TLWQS, the Board held a public hearing and reviewed MWRD's demonstration and the Illinois Environmental Protection Agency's recommendation, as well as public comments from other participants, including the United States Environmental Protection Agency (USEPA). The TLWQS will take effect for federal Clean Water Act purposes after approval by USEPA. The ultimate objective remains compliance with the underlying dissolved oxygen water quality standards, which still apply in the CAWS to all discharges not covered by the TLWQS.

#### TIME-LIMITED WATER QUALITY STANDARDS

#### Restricted Status/Critical Review

The Environmental Protection Act prohibits the Agency from issuing a construction permit that will cause or extend a violation. A construction permit to expand the distribution system cannot be granted when a water supply has a maximum contaminant level or treatment technique violation, an inadequate source of raw water supply, inadequate treatment plant capacity, finished water storage or distribution system pressure. A Restricted Status List is published quarterly in the Illinois Pollution Control Board Environmental Register to notify those persons considering expansion of a water supply distribution system of that status before large sums of money have been spent on items such as land acquisition, financing and engineering fees. A companion Critical Review List is published concurrently with the Restricted Status List and has the water supplies that are approaching a point where the supply could be placed on Restricted Status. A permit application from a supply on Critical Review will be examined



carefully to ensure that the proposed construction will not cause a violation. Restricted Status and Critical Review are presented as a combined list with the status of the water supply denoted as either RS (Restricted Status) or CR (Critical Review). The current list reflects the status as of December 11, 2020. An asterisk, \*, beside the water supply indicates public water supplies that have been added to the Restricted Status/Critical Review list since the previous publication.

#### Restricted Status List

The Restricted Status List was developed to give additional notification to officials of public water supplies which are in violation of 35 Ill. Adm. Code, Subtitle F: Public Water Supplies, Chapter I or the Illinois Environmental Protection Act.

The Restricted Status List will include all Public Water Supplies for which the Agency has information indicating a violation of any of the following requirements: Finished water quality requirements of 35 Ill. Adm. Code, Part 604, Subparts B and C; maintenance of adequate pressure on all parts of the distribution system under all conditions of demand; meeting raw water quantity requirements of 35 Ill. Adm. Code 604.502; or maintenance of treatment facilities capable of providing water "assuredly adequate in quantity" as required by Section 18 of the Illinois Environmental Protection Act.

A public water supply on the Restricted Status List will not be issued permits for water main extensions, except for certain limited situations, or unless the supply has been granted a variance from the Illinois Pollution Control Board for the violation, or from permit issuance requirements of Section 39 of the Act. This list is continually being revised as new information becomes available, and therefore, specific inquiries as to the status of any public water supply should be directed to the Division of Public Water Supplies for final determination.

#### Critical Review List

The Critical Review List was developed to give additional notification to officials of public water supplies which may be close to being in violation of 35 Ill. Adm. Code, Subtitle F: Public Water Supplies, Chapter I or the Illinois Environmental Protection Act.

A supply will be placed on the Critical Review List when Agency records indicate that it is approaching any of the violations that would place it on the Restricted Status List.

This list is continually being revised as new information becomes available, and therefore, specific inquiries as to the status of any public water supply should be directed to the Division of Public Water Supplies for final determination.
