
**HEARING OFFICER ORDER**

On August 22, 2022, all parties participated in telephonic status conferences with the hearing officer. A hearing was scheduled and noticed for September 28, 2022, and continue to September 29, 2022, if necessary. Also on August 22, 2022, the petitioner filed an additional waiver of the statutory decision deadline to and including December 15, 2022. The petitioner also filed a proposed and agreed discovery schedule.

The discovery schedule is accepted and is as follows: Respondent to answer written discovery on or before September 1, 2022; Depositions must be completed on or before September 20, 2022. The agreed post-hearing briefing schedule is as follows: The parties to file simultaneously opening briefs on or before October 21, 2022; The parties to file simultaneously responses on or before November 9, 2022. Public Comment due to be filed on or before October 14, 2022. The record closes on November 9, 2022.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on September 12, 2022, at 1:00 p.m. The telephonic status conference must be initiated by the petitioner, and provide a call-in number, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


