ORDER OF THE BOARD (by C.M. Santos):

On September 15, 2022, the Illinois Environmental Protection Agency (IEPA) filed a recommendation (Rec.) that the Board not certify specified facilities of Malone Chemical, Inc. (Malone Chemical) as "pollution control facilities" for preferential tax treatment under the Property Tax Code. See 35 ILCS 200/11-5 et seq. (2020); 35 Ill. Adm. Code 125. Specifically, IEPA recommends that the Board deny a tax certificate for Malone Chemical's liquid fertilizer tank with synthetic membrane liner at its agrichemical facility located 34691 East 2300 North Road in Kempton, Livingston County. Rec. at 3. IEPA states that the storage tank and liner "do not have the primary purpose of eliminating, preventing, or reducing water pollution, . . . and are not eligible for tax certification from the Board. Id. at 2, citing 35 Ill. Adm. Code 125.200(a) (Pollution Control Facilities) (emphasis in original).

If Malone Chemical wished to contest IEPA's recommendation, it was required to file a petition to contest with the Board's Clerk within 35 days after IEPA served Malone Chemical with its recommendation. Malone Chemical has failed to timely file a petition to contest IEPA's recommended denial. *See* 35 Ill. Adm. Code 101.300(c)(4), 125.206(a). Accordingly, based on IEPA's recommendation and the Board's technical review, the Board denies tax certification.

## IT IS SO ORDERED.

Section 11-60 of the Property Tax Code provides that any applicant or holder aggrieved by the issuance, refusal to issue, denial, revocation, modification or restriction of a pollution control certificate or a low sulfur dioxide emission coal fueled device certificate may appeal the Board's finding and order to the Circuit Court under the Administrative Review Law (735 ILCS 5/3-101 *et seq.* (2020)). See 35 ILCS 200/11-60 (2020). Within 35 days after receiving this final Board order, a party to this Board proceeding may file a motion asking the Board to reconsider or modify the order. 35 Ill. Adm. Code 101.520. Filing a motion to reconsider this final Board order is not a prerequisite to appealing the order. 35 Ill. Adm. Code 101.902.
