HEARING OFFICER ORDER


On November 10, 2022, all parties participated in a telephonic status conference with the hearing officer. Discussions centered on the following. On November 7, 2022, respondent filed a motion for extension of time to file an answer or other pleading to November 21, 2022. On November 9, 2022, complainant filed motion to dent respondent’s motion. Respondent’s motion is granted and its answer or other pleading is due November 21, 2022.

On November 9, 2022, respondent filed an unopposed motion for leave to withdraw appearance and file an amended appearance. (Mot.). Respondent’s attorney states that his original appearance was for the “Lisle Township Highway Department”. Mot. at 2. However, the correct entity is “Lisle Township Road District”. *Id.* Respondent states that complainant has no objection. *Id.* Respondent’s motion is granted. The above caption will reflect the correct entity.

The parties were requested to submit a discovery schedule by December 2, 2022.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on December 5, 2022, at 8:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. Respondent is directed to supply a telephone number to be conferenced in. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.
