

**HEARING OFFICER ORDER**

On December 13, 2022, all parties participated in the above-captioned consolidated matter. Counsel for Midwest Generation, LLC., stated that petitioner is awaiting the respondent to incorporate the relief granted in PCB 38 & PCB 39 for the Joliet Stations into their NPDES Permit. Counsel will file an additional motion to stay the proceedings. Counsel for INEOS Joliet, LLC., reported that it has met with respondent recently discussing their comments on the petitioner's Demonstration document and will continue discussions and any follow-up questions and comments.

The parties or their legal representatives in PCB 16-19 are directed to participate in a telephonic status conference with the hearing officer on March 2, 2023, at 10:00 a.m. The parties or their legal representatives in PCB 16-24 are directed to participate in a telephonic status conference with the hearing officer on March 2, 2023, at 10:15 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




