**PROTECT WEST CHICAGO’S NOTICE OF CORRECTED SERVICE LIST AND
NOTICE OF RE-SERVICE OF THE PETITION FOR HEARING & REVIEW OF

NOW COMES Petitioner, Protect West Chicago, (“PWC”), by and through its attorney, Meza Law, and hereby files Protect West Chicago’s Notice of Corrected Service List and Notice of Re-Service of the Petition For Hearing & Review of Local Siting Approval for New Pollution Control Facility upon George Mueller, counsel for Lakeshore Recycling. In support hereof, PWC states as follows:

1) On March 28, 2023, PWC filed its petition with the Illinois Pollution Control Board (“PCB”) for hearing on and review of the decision of the City of West Chicago’s City Council granting site location approval to Lakeshore Recycling Systems, LLC (“Lakeshore” or “Applicant”) for the proposed West DuPage Recycling and Transfer Station, located at 1655 Powis Road, West Chicago, IL pursuant to Section 40.1 of the Illinois Environmental Protection Act, 415 ILCS 5/401.1, in accordance with Sections 107.200 through 107.208 of the PCB procedural rules, 35 Ill Admin. Code §§ 107.200-208.

2) On March 28, 2023, per the PCB procedural rules, PWC served its Petition and related filings (Appearance, Consent of Receipt of Email Service) to all interested parties identified in the initial Service List via U.S. certified mail, as well as U.S. mail, postage prepaid.

3) On March 28, 2023, PWC also emailed a copy of all PCB filed pleadings to counsel identified in the initial Service List.
