

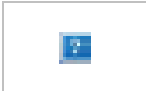

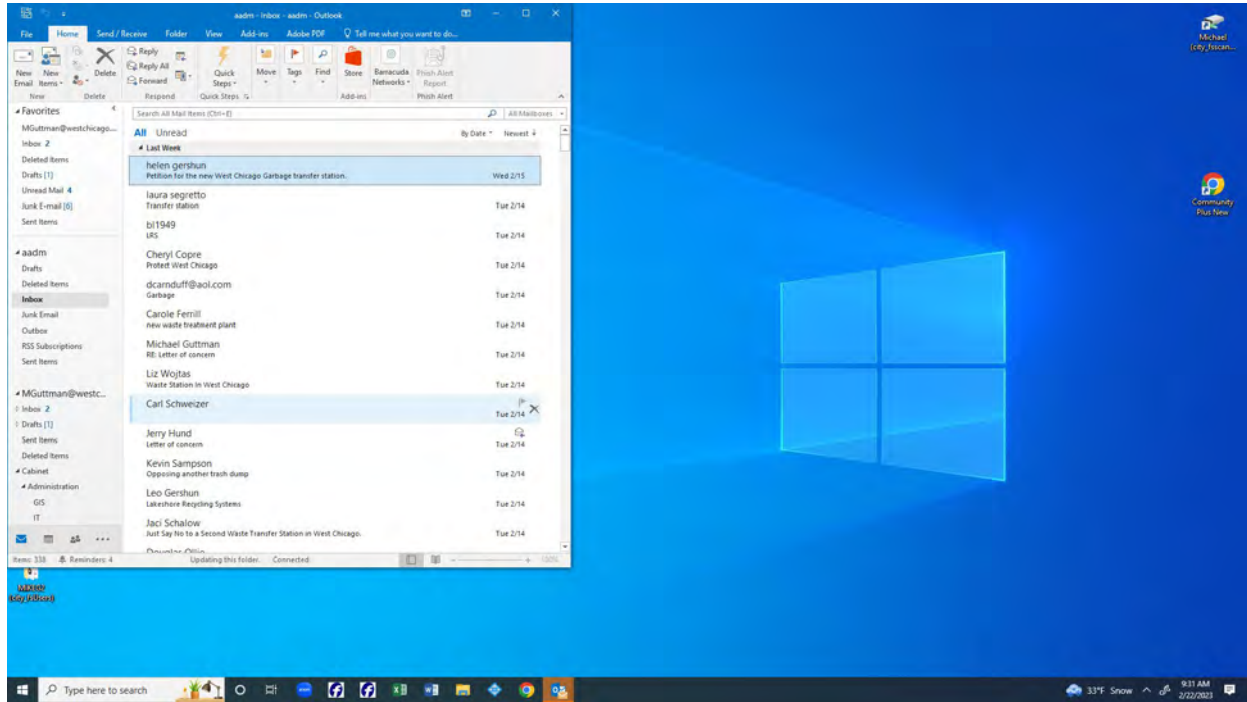

Good morning Hearing Officer Price, counsel & West Chicago's designated public comment in-box,

I write to you and the City's email in-box designated for public comment to raise an issue that speaks directly to the fundamental unfairness of this proceeding.

To confirm the contents of the record this morning, I reviewed the City's formal collection of public comments submitted in this matter – available when one selects "View Submitted Public Comments" at <https://westchicago.org/transferstation/comment>. The comment timely and properly submitted by PODER, see attached, has been omitted from this 114-page packet. This inexplicable and inexcusable omission indicates that the City has elected not to include PODER's public comment in the set that will be reviewed by the City Council. PODER objects and requests that the City include PODER's public comment for consideration by the City Council.

Furthermore, I note that City's compilation of public comments that will be considered by the City Council does include the materials improperly submitted by LRS's council to you, rather than to the City, as instructed by the City on its website. As further explained in our filing yesterday, see page 30 n.5, PODER objects.

Finally, and relatedly, PODER objects to the additional burden placed on a grassroots community organization to independently confirm that the City is properly processing public comments under the City's own instructions, a burden created by the City's failure to treat PODER's submissions with the same consideration as those of other public commenters. Indeed, the City seems to have bent its rules for LRS, while mistreating and omitting PODER's comment that was submitted in accordance with City instructions.

I am sorry to have to write this message, but am happy to discuss. I appreciate your time and attention to this matter.

The comment timely and properly submitted by PODER, see attached, has been omitted from this 114-page packet. This inexplicable and inexcusable omissions indicates that the City has elected not to include PODER's public comment in the set that will be reviewed by the City Council. PODER objects and requests that the City include PODER's public comment for consideration by the City Council.

Furthermore, I note that City's compilation of public comments that will be considered by the City Council *does* include the materials improperly submitted by LRS's council to you, rather than to the City, as instructed by the City on its website. As further explained in our filing yesterday, see page 30 n.5, PODER objects.

Finally, and relatedly, PODER objects to the additional burden placed on a grassroots community organization to independently confirm that the City is properly processing public comments under the City's own instructions, a burden created by the City's failure to treat PODER's submissions with the same consideration as those of other public commenters. Indeed, the City seems to have bent its rules for LRS, while mistreating and omitting PODER's comment that was submitted in accordance with City instructions.




