
HEARING OFFICER ORDER

On January 18, 2024, all parties and participants participated in a telephonic status conference. Discussions centered on a hearing date, time, and location, regarding the Stipulation to be challenged. The City of LaSalle attorney will confirm that February 29, 2024, at 10:00 a.m. is acceptable for the use of the courtroom.

One of the participates inquired as to whether a recording for a documentary would be allowed during the hearing. I directed the participant to file a written motion requesting the allowance of the recording on or before January 25, 2024. The complainant and the respondent were directed to respond on or before February 1, 2024.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on February 15, 2024, at 12:30 p.m. The telephonic status conference must be initiated by the complainant, and provide a call-in number, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




