NOTICE OF PROPOSED STIPULATION AND PROPOSAL FOR SETTLEMENT OF ENFORCEMENT CASE The Attorney General has brought a case against Jay Shri Ganesha Inc., d/b/a Shivam Energy, Inc. and d/b/a Marathon Gas for violating State pollution control rules. On June 17, 2024, the parties filed a stipulation and proposal for settlement. The parties agree that a hearing is unnecessary, and in accordance with State law, have requested that the settlement be adopted without holding a cordance with State law, have requested that the settlement be adopted without holding a public hearing.
