

ILLINOIS POLLUTION CONTROL BOARD

MINUTES OF INFORMAL BOARD MEETING  
May 24, 1971 Chicago, Illinois

Mr. Currie was absent and Mr. Lawton conducted the meeting. The following matters were discussed:

1. Southern Illinois Asphalt, #71-31. Mr. Lawton agreed to prepare an opinion directing the company to cease and desist operation of its present site and impose a fine of \$5,000.00
2. EPA v. Borden Chemical Co., #71-23. Mr. Kissel presented an opinion in this case establishing timetables and compliance schedules with SWB-14 as follows:
  - "1. Borden is hereby required to meet the following timetable for the construction of advanced waste treatment facilities as required by paragraph 11b, Section 1.08, SWB-14.
    - a. Completion of plans and specifications - October 31, 1971;
    - b. Awarding of construction contracts - February 1, 1972; and
    - c. Completion of construction - July 1, 1972"The opinion and order were adopted by the Board.
3. EPA v. Norfolk & Western Railway, #70-41. An Order was discussed finding no violation of particulate emission regulations as alleged by the Agency. Tests introduced by the railroad negated application of the standard emission factors offered by the EPA and opinion prepared by Mr. Currie will be submitted for adoption at the May 26, 1971 meeting.
4. EPA v. Allied Mills, #71-16. Order was approved subject to later opinion directing the company to divert its storm waters and process waste waters to an irrigation field until such time as its effluent meets the requirements of SWB-14 to be achieved by July 1, 1971. Performance bond in the amount of \$25,000.00 was directed.
5. EPA v. Sauget, #71-29. Opinion and order were discussed to be adopted at the May 26, 1971 meeting directing Respondent to cease and desist various violations of the Rules and Regulations for Refuse Disposal Sites and Facilities, and imposing a penalty in the amount of \$1,000.00.

6. EPA v. City of Springfield, Springfield City Water, Light & Power Company, #70-9. Opinion was discussed to be adopted May 26 denying motion by the EPA to file an amended complaint confirming the pleadings to the proof, the motion having been filed too late to be granted.
7. EPA v. Danville Sanitary District, #71-28. Opinion prepared by Mr. Dumelle was discussed and set for adoption at the May 26, 1971 meeting. The opinion and order would direct respondent to comply with SWB-9 pertaining to BOD and suspended solids by June 1, 1971, which could be achieved by installation of temporary treatment facilities. By September 1, 1971, the district is to submit completed plans and schedules for permanent facilities. A sewer ban was to be imposed until acceptable treatment has been achieved. Odor control facilities are to be installed and a performance bond required.
8. NSSD v. EPA, #71-36 variance request was discussed. Mr. Dumelle agreed to prepare an opinion for adoption at the June 9, 1971 meeting, which opinion and order would deny the phosphate variation request as to water quality standards and effluent standards. Also discussed was the compliance program of the entire NSSD operation. Dates were to be established for completion of the North Chicago and Waukegan facilities for secondary treatment, establishing both interim and final dates. Chemicals were to be used at all lakefront plants and Clavey Road. Overflow was to be screened. Secondary treatment deadlines were to be achieved on the basis of the District's representation and approval for revision of 1973 deadlines would be sought from the Federal government.

The following regulations were discussed:

#R70-12 - Desplaines River Water Quality Standards. Mr. Kissel agreed to prepare an opinion for adoption at the June 9, 1971 meeting incorporating the proposed improvement of the Desplaines River Water Quality Standards with Hearing #R71-14, the comprehensive revisions of the water quality standards.

#R71-3 - Ohio River Treatment Dates. Opinion and Order were proposed by Mr. Dumelle for adoption May 26, 1971, advancing secondary treatment dates on the Ohio River to December 31, 1973.

#R71-11 - Water Quality Standards for Public Water Supply. Use and Food Processing. Opinion and order were proposed by Mr. Dumelle for adoption May 26, 1971. The regulation would amend SWB-7 through 15 inclusive, requiring that waters designated for food processing and water supply use meet U. S. Public Health Service Drinking Water Standards of 1962.

#R71-12 - Temperature Standards for the Wabash and Ohio River. Approval of the original version as submitted, was tentatively agreed upon by Messrs. Lawton, Kissel and Dumelle. Mr. Aldrich expressed disagreement.

#R71-13 - Shawneetown. Opinion and order proposed by Mr. Currie for adoption May 26, 1971 were discussed. The regulation would amend SWB-10 by the addition of the Village of Shawneetown to the waste facilities timetable as proposed by the Federal EPA. Correspondence indicated Shawneetown waste discharges are subject to SWB-14 and not SWB-10, and accordingly, #R71-13 would be dismissed.

The meeting was then adjourned.
