MINUTES OF REGULAR BOARD MEETING

October 31, 1972 309 W. Washington, Chicago

All Board members were present.

Opinions and orders were adopted in the following cases by a vote of 5-0: ##71-293, 15th Street Auto; 72-151, Harshany; 72-265, J.C. Dill; 72-267, Farley; 72-298, General Classics; 72-331, Glasford, dismissed, Mr. Currie to supply an order; 72-338, Mattison; 72-357, Olin; 72-368, 377, Cinnamon Creek, opinion only.

#72-79, Sangamo was put over to the afternoon session and #72-83, Cilco, was put over to Nov. 8, 1972.

#72-286, Evanston, motion to adopt H.O. orders was put over pending receipt of briefs.

Decisions in ##72-330, Mt. Carmel and 72-336, Monsanto were put over to the afternoon session.

#72-339, Liberty Financial was placed on Nov. 8 agenda for decision.

Parties were present in #72-76, Fansteel and respondent filed an amendment to the original proposal for settlement. The Board approved the settlement by a vote of 5-0. Mr. Dumelle agreed to prepare an order so stating and to prepare a draft opinion for Nov. 8.

An additional statement was filed by the Agency in #72-81, Tee-Pak. Mr. Henss agreed to prepare an opinion for Nov. 8.

Discussions were held and cases set for decision Nov. 8 in the following: ##71-300, Hoffman, Mr. Lawton to prepare an opinion; 72-72, Kienstra, Mr. Henss to prepare an opinion; 72-80, Harrisburg, Mr. Dumelle to prepare an opinion; 72-175, W. Frankfort, Mr. Parker agreed to draft an opinion; 72-230, C.M. Ford, Mr. Currie said he would prepare an opinion; 72-313, 314, Lansdowne & Cahokia, Mr. Parker to prepare an opinion.

Further discussion was held in #72-253, Olin. Parties were present.

Parties were present in #72-398, N. Chicago, The Board granted the Open Burning variance by a vote of 5-0. Mr. Lawton to supply an order and prepare an opinion for Nov. 8.

In #72-375, Meyer V. Jefferson Park, a hearing was authorized by a vote of 5-0.

Mr. Currie's opinion in #72-79, Sangamo was adopted by a vote of 5-0.

In #72-330, Mt. Carmel, variance granted by a vote of 5-0 and Mr. Currie said he would supply an opinion and order.

Variance granted 5-0 in #72-336, Monsanto, and Mr. Dumelle agreed to supply an opinion and order.

A motion for clarification in #71-343, NSSD, by Capital Development Board was denied by a vote of 5-0. Mr. Currie will supply an order.

No action was needed in #72-309, Trilla on a motion to dismiss as it went to the merits of the case.

In #72-383, Apple Orchard, motion to extend time for filing an amended petition was granted 5-0. Mr. Parker will supply an order.

Motion for temporary variance in #72-416, Incinerator was denied by a vote of 5-0. Mr. Currie said he would supply an order.

In new cases these actions were taken: ##72-418, Capitol Development Board, put over to Nov. 8 at the Agency's request; 72-419, Lonza, Inc. hearing authorized; 72-420, Pekin Lake Conservation, hearing authorized; 72-421, Imperial Smelting, hearing authorized; 72-422, Emmanuel Hanna, verification requested of petitioner and hold for EPA recommendation; 72-423, General Iron, hearing authorized.

A proposal filed by Citizens against Noise (#R72-16) regarding toy noise was dismissed by a vote of 5-0. Mr. Lawton agreed to prepare the order.

A motion for stay in #71-338, CPC International was granted 5-0. Mr. Currie will supply the order.

Motion to vacate in #72-288, ACME Solvents needed no action and the Board placed case on agenda for discussion Nov. 8.

Mr. Sikevitz gave a status report on Steel Companies' Motions for Stay hearings.
