MINUTES OF REGULAR BOARD MEETING
November 21, 1972 Chicago, Illinois

All Board members were present.

Decisions in ##71-364, Augusta, and 72-76, Fansteel (opinion only) were put over to November 28.

Opinions and orders were adopted in the following cases by a vote of 5-0: ##72-80, Harrisburg; 72-162, Geiss; 72-170, Bradley-Roper.

Decision in #72-209, Monsanto, was put over to November 28 and after some discussion #72-253, Olin, was put over to November 28 for decision.

Motions filed in #72-366, Weinstein, were put over pending receipt of the record.

Mr. Walter Romanek of the Federal E.P.A. gave a status report on the new Federal Water Bill.

The Board adopted opinions by a vote of 5-0 in: ##72-344, Best; 72-401, Sherwin-Williams; 72-443, Lena.

Opinion in R72-11, Open Burning, was put over to November 28. Decision pending receipt of final transcripts.

These cases were discussed and set for decision November 28; ##72-13, Will County Landfill, Mr. Henss to prepare an Opinion; 72-125, Swift and Co., Mr. Dumelle to prepare an opinion; 72-204, Union Electric, Mr. Lawton to prepare an opinion; 72-215, Weldon, Mr. Lawton to prepare an opinion for possible discussion; 72-248, Coulterville, Mr. Currie said he would prepare an opinion; 72-274, Mid-City, Mr. Parker to prepare an opinion; 72-388, Ehredt, Mr. Currie to prepare an opinion; 72-435, Enterprise, Mr. Dumelle to prepare an opinion; 72-416, Incinerator, Mr. Currie said he would prepare an opinion; 72-424, Scott Air Force, Mr. Currie to prepare an opinion.

Additional information in #72-409, Sterling Park Dist. was noted filed and the Board authorized it for hearing 5-0.

In #72-425, Laclede, the Board responded to a motion to dismiss by the E.P.A. by voting 5-0 to allow the petitioner to amend its petition. Mr. Lawton will prepare an order.

A motion regarding penalties in #71-243, 15th St., was put over pending E.P.A. response.

In new cases: ##72-442, Foss Park, ordered held for EPA recommendation; 72-445, Zelen, additional information requested 5-0, Mr. Parker to prepare an order; 72-446, Bensenville, dismissed 5-0, Mr. Dumelle to prepare an order; 72-447, Union Oil Co. of California, hearing authorized 5-0; 72-448, Gallatin-White, hearing authorized 5-0; 72-449, Wineman, hearing authorized 5-0; 72-450, Olin Corp., ordered held for EPA recommendation; 72-451, North Shore Sanitary Dist. hearing authorized 5-0.

A proposed regulation on Farm Grain Dryers (R72-18), filed by the E.P.A. was ordered set for hearings.

General discussions on the status of old cases and court reporting services were held. Mr. Henss and Mr. Lawton said they would possibly meet with Mr. McCorkle of the court reporting service to discuss some of the problems with transcripts. The Board decided to ask Mrs. Wiley to investigate alternatives with regard to court reporting services.
