

ILLINOIS POLLUTION CONTROL BOARD

MINUTES OF REGULAR INFORMAL BOARD MEETING
DECEMBER 13, 1971, 309 W. WASHINGTON ST., CHICAGO, ILL.

All Board members were present.

Mr. Currie's proposed opinion and order denying the variance in # 71-276, Cianciara, were adopted 5-0.

After discussion ## 71-298 and 71-312, Waukegan and Custom Farm Service, were set for decision Dec. 21, Mr. Kissel agreeing to revise the penalty in the former case to \$1000 for the City and \$250 for the other respondents, Mr. Currie saying he would file a concurring opinion, and Mr. Dumelle suggesting the penalties should be higher.

After discussion the following draft opinions were assigned for discussion December 20: ## 71-211, Agrico Chemicals, Mr. Currie: to approve the particulate program for July 1972 completion on condition of a \$10,000 penalty; 71-261 to -264, Central Illinois Public Service Co., Mr. Kissel: to examine the March 1973 date for Coffeen #1, to find no proven sulfur dioxide violation, to allow Hutsonville hot standby until fall 1972 but to forbid any operation after Jan. 1, 1974 without controls; to allow until March 1972 for a precipitator at Meredosia; and until Sept. 30, 1972 for cold standby at Grand Tower. 71-287, Sauget, Mr. Dumelle: to allow until December 31, 1974 for completion of a complex secondary plant largely for industrial effluents on the Mississippi; 71-295, Lincoln, Mr. Aldrich: to allow an extra year for compliance with the algae requirements of TP 20-24; 71-315, McClellan, Mr. Lawton: to deny a variance from the covering requirements for bulk landfill for failure to show arbitrary hardship, reserving the correctness of the regulations for rule-making hearings soon to be held. Discussion of # 71-238, General Electric, was postponed until Dec. 20.

Mr. Currie and Mr. Kissel asked that the Water Quality Standards, #R 71-14, be issued as a proposed final draft Dec. 21, since the revised Green Book that might indicate desired changes would not be available for six months. Mr. Dumelle disagreed, and the matter was set for December 21 resolution. Mr. Currie agreed to add an alternative permit provision to the proposed regulation on sewer connection bans, #R 71-19, dispensing with the reservation proposal, and to have the matter ready for hearing authorization Dec. 21.

Action on the motion to reduce bond in #71-15R, Mt. Carmel, was postponed awaiting EPA response. Mr. Currie agreed to request an EPA response to the request for additional connections in # 71-28, Danville SD, and to prepare a draft opinion for discussion Dec. 21 to deny the request because of upset conditions and an unsatisfactory effluent. The suggestion of nonliability by respondent Horsch in # 71-269, Glovka v. NSSD, was left to be taken at the hearing. The motion to dismiss as moot in # 71-306, Tollway, on account of the filing of the desired statement, was deferred awaiting a response as to the adequacy of the statement. ## 71-378, Chesterfield, and 71-380, Highland Park Hospital, were deferred after discussion until December 20, Mr. Lawton not participating. # 71-379, State Training School, was dismissed 5-0 for inadequacy of the petition, Mr. Currie to supply an order. In # 71-381, Petersen, an EPA complaint, a hearing is mandatory. The motion to vacate the preliminary order in # 71-325, Airtex, was deferred until final action on the case. In # 71-363, Venable, Mr. Currie agreed to prepare an order granting the connection variance for action December 21, since verification of the petition had been received.

Mr. Dumelle suggested the Board read the transcripts in the Nutrient hearings just completed, # R 71-15, and schedule the matter for early discussion.

The Board agreed to implement Mr. Dwyer's report on public information, and Mr. Currie was asked to look for a candidate for the post. Mr. Dumelle and Mr. Kissel expressed willingness to attend the EPA-federal-NIPC meeting on regional sewage planning January 10.
