MINUTES OF REGULAR BOARD MEETING
April 26, 1973 Chicago, Illinois

All Board Members were present save Mr. Lawton who was on vacation.

A motion in #73-122, Village of Morton for extension of time to file an amended petition was granted by a vote of 3-0. Mr. Dumelle will prepare an order.

Motion for extension of time to file briefs by W. S. Brewers et al in #R71-24, Beverage Containers, was granted by a vote of 3-0. Mr. Dumelle will prepare the order.

#72-148, Processing & Books was discussed by Mr. Henss and set for discussion and possible decision May 3, 1973.

Decisions in these cases were put over to May 3: ##72-463, Citizens v. Proctor & Gamble; 72-481, Bensenville; 72-518, Reynolds (Opinion only); 73-1, Rockford.

Variance was granted in #73-43, Miller by a vote of 3-0. Mr. Dumelle will prepare the Opinion and Order.

These cases were put over to May 3, for further discussion: #72-70, S. W. Regional Port Dist.; 73-68, McMackin; 73-69, MSD; 73-98, American Limestone.

Hearing to continue as authorized in #73-88, Deere, since the E. P. A. recommended denial of the variance.

European Motor Sport, held over to May 3 for discussion; 73-165, Leo Anderson, hold for EPA recommendation; 73-167, Loretta Jeffress, hold for EPA recommendation.
