

ILLINOIS POLLUTION CONTROL BOARD

Minutes of Regular Board Meeting  
May 10, 1973 Chicago, Illinois

All Board Members were present.

Opinions and orders were adopted by a vote of 4-0 in: ##72-70, S.W. Regional Port Dist.; 72-148, Processing & Books; 72-152, Flintkote.

An order granting variance request was adopted in #72-410, R.R. Donnelley by a vote of 4-0. An opinion in #72-410, R.R. Donnelley and #72-472, E.P.A. v. R.R. Donnelley was set for decision May 17, 1973.

Decisions in ##72-392, Aurora and 72-463, Citizens v. Proctor & Gamble were put over to May 17, 1973.

An opinion was adopted in #73-69, Metropolitan Sanitary District by a vote of 3-0. Mr. Seaman did not participate in the discussion or decision of the matter.

Opinions and orders were adopted by a vote of 4-0 in ##73-112, Holland and 73-49, Aurora Blacktop.

Motion to amend in #71-129, Commonwealth Edison was put over to May 17, 1973.
