Minutes of Regular Board Meeting May 24, 1973 Chicago, Illinois

All Board Members were present.

Mr. Richard Cosby of the Attorney General;s office reported to the Board on matters of appeal. The Board voted to appeal the denial of the Board's motion to intervene in Western National Bank. The Board also voted to intervene in the matter of Robert Nilles.
