

ILLINOIS POLLUTION CONTROL BOARD

Minutes of Regular Board Meeting
October 4, 1973 Chicago, Illinois

All Board Members were present.

An Opinion and Order were adopted in #71-104, Gages Lake by a vote of 4-0. Mr. Marder abstained.

Opinions and Orders were adopted in these cases by a vote of 5-0: ##73-185, Central Illinois Public Service; 72-52, 48 Insulations; 73-209, Consumers Grain.

These cases were discussed and set for Decision on October 11: ##73-34, Acme; 73-238, Clark Oil.

Attorney for Petitioner was present in #73-292, Addressograph and asked that Decision be put over. The Board agreed and a waiver of 90 day decision due date was filed.

In #71-243, Carlson, motion to approve program or extend variance was put over pending receipt of Agency response.

Motions for reconsideration in ##71-381, Peterson and 73-77, Danville were discussed and put over to October 11, 1973.

Motion to reconsider in #73-150, Bressler was denied 4-0. Dr. Odell abstained. Mr. Seaman will prepare an order.

Motion for modification in #72-477, G. E. was discussed and set for Decision on October 11, 1973.

An Opinion and Order was adopted 5-0 in ##72-491, 72-492, 73-40, Commonwealth Edison.

Motion to grant variance without hearing in #73-362, Fields, Goldman & Magee was denied 4-0, Mr. Seaman was not present. Mr. Dumelle will prepare an order.

Motion by the Agency for extension of time to file a recommendation in #73-382, Allied Chemical was allowed 4-0, Mr. Seaman was not present. Mr. Henss will prepare an order.

Motion for stay in #R72-2, Noise Regs. by Shell Oil was ordered held pending receipt of Agency response.

The matter of #R73-11, Implementation of the National Pollutant Discharge Elimination System filed by the Agency was authorized for publication and hearing. An additional proposal filed by the Federal E. P. A. was ordered consolidated with R73-11 for hearing.
