Minutes of Regular Board Meeting
January 31, 1974 Chicago, Illinois

All Board Members were present.

Opinions and Orders were adopted in these cases by a vote of 5-0: ##71-308, Martin; 73-33, Ill. Slag; 73-417, Hinsdale; 73-411, Du Pont; 73-474, Ferguson; 73-475, Lewis University; 73-478, 48 Insulations; 73-498, Carsons International (additional information order); 73-534, Great Lakes Carbon, dismissed.

An opinion was adopted in #73-313, Union Carbide by a vote of 4-1. Mr. Dumelle dissented.

Motion for hearing in #73-478, 48 Insulations was denied 5-0. Mr. Marder will prepare an Order.

In #73-288, Highland, Petitioner agreed to file an amended petition and waiver of time.

Motion to modify in ##73-55 and 73-174, Eckrich & Kneip was granted 5-0. Dr. Odell will prepare an order.

Motion for post-hearing relief in #73-156, Borg-Warner was granted 5-0. Mr. Henss will prepare an order.

Motion for reconsideration in #73-337, Medusa was ordered docketed as a new variance petition and ordered held for an Agency Recommendation. Mr. Henss will prepare an order.

Motion to modify in #73-388, Armour-Dial was granted 5-0. Mr. Dumelle will prepare an order.

Motion for order in #73-458, Continental Can was held to February 7, 1974 for action.

Motion for amendment of order in #73-482, Ill. Power was granted 5-0. Mr. Seaman will prepare an order.

Motion to treat petition as petition to intervene was granted in #73-513, Martin by a vote of 5-0. Mr. Dumelle will prepare an order.
