

ILLINOIS POLLUTION CONTROL BOARD

Minutes of Regular Board Meeting
April 25, 1974 Champaign, Illinois

All Board Members were present.

Dr. Odell welcomed the public in attendance and introduced the Board Members.

Opinions and orders were adopted by a vote of 5-0 in these cases: ##73-21, Herrin; 73-456, Loves Park; 73-529, Bradley; 74-8, AMF; 74-55, Reflector; 74-56, W. R. Meadows; 74-57, Monsanto; 74-63, Koppers, 74-72, Westinghouse.

Orders on pending cases ##72-276, Aurora Sanitary District and 72-516, Edwin Cooper were discussed and set for decision May 2, 1974.

Public comments were invited and the Board answered questions regarding citizen enforcement actions, citizen participation and costs involved.

Motion for stay in ##71-348 and 72-73, Darling was granted as to penalty only by a vote of 5-0.

Motion for hearing in #73-546, Ill. Gulf was granted 5-0. Mr. Dumelle will prepare an order.

Motion to extend time in #74-75, Great Lakes Carbon was granted 5-0. Mr. Dumelle will prepare an order.

In #74-103, CBE v. Ill. EPA et al action was held to May 2, 1974 after some discussion of a proposed order.

##R72-18, Farm Grain Dryers and R74-3, Laundry Institute of Chicago were ordered for hearing and publication in the Board's Newsletter by a vote of 5-0.

These cases were discussed and set for further discussion or possible decision May 2, 1974: 72-425, -505, Laclede Steel; 73-42, -145, G.E. and Hotpoint; 73-532, Moss-American; 74-10, Illinois Power; 74-61, Harrisburg; 74-62, Mt. Olive.

Mr. Dumelle announced changes in the Board meeting schedule.

Motion for stay of Noise Regs., R72-2, by Rockford Drop Forge was discussed and ordered placed on the Agenda for May 2, 1974

The Board asked the Clerk to request that the assigned hearing Officer vacate his order consolidating Alton Box Board cases (#73-61, #74-5 and #74-51) and ask that the parties submit motions for consolidation to the Board.

In new cases these actions were taken by a vote of 5-0: ##74-140, EPA v. Western Piece Dyers, hearing mandatory; 74-141, Acme Barrel, additional information requested and hold for Agency recommendation, order by Mr. Marder; 74-142, Du Pont, additional information requested and hold for Agency recommendation, order by Mr. Dumelle; 74-143, Master Tank and Welding, ordered held for Agency recommendation; 74-144, Fremont School District, ordered held for Agency recommendation and additional information, order by Mr. Dumelle.

Public comments were requested. A "Layman's" summary of procedures and citizen participation was requested by the Chairman of H. I. P. S.

All matters not disposed of as listed were ordered placed on the Agenda for May 2, 1974.
