Minutes of Regular Board Meeting
May 9, 1974 Chicago, Illinois

All Board Members were present.

Opinions and orders were adopted by a vote of 5-0: ##73-326, Dext; 73-454, Early & Daniel; 73-538, Deere & Co.

An order approving permit by Ill. Dept. of Transportation was adopted 5-0. Mr. Dumelle will prepare an order.

Motions in these cases were discussed and held to May 16: ##72-114, Apex; 73-384, CIPS; 74-79, Glidden-Durkee; 74-129, Illini Community Hospital.

Motion to withdraw in #74-98, American Air Filter was allowed 5-0. Mr. Dumelle will prepare an order.

Motion to withdraw in #74-125, GATX was allowed 5-0. Mr. Dumelle will prepare an order.

Motion to withdraw in #74-90, Ridgeview, was allowed 5-0. Dr. Odell will prepare an order.

Motion to consolidate ##74-169 and 73-517, Ill. Nitrogen was allowed 5-0. Mr. Dumelle will prepare an order.

An order in R73-13, Public Water Supply was adopted 5-0 keeping the record open until May 24,

An order in #72-412, Trione was adopted 5-0 requesting briefs from the parties.

Opinions and orders were adopted in ##74-95, Celotex and 74-113, R.R. Donnelley by a vote of 5-0.
