Motion for rehearing on the counter-complaint in #73-316, Citizens Utilities was denied 4-0. Mr. Marder will prepare an order.

Motion to return exhibits in #73-236, Viking Investment was allowed for 60 days by a vote of 4-0. Mr. Marder will prepare an order.

#74-161, Urbana was ordered re-assigned to the Hearing Officer handling #73-527, Champaign.

Motion to dismiss in #74-168, Carboline was granted 4-0. Mr. Seaman will prepare an order.
