MINUTES OF REGULAR BOARD MEETING
July 18, 1974, CHICAGO, ILLINOIS

All Board Members present.

Opinions and Orders were adopted by a vote of 5-0 in these cases: ##
73-245, 73-248, CBE v. Commonwealth Edison and Commonwealth Edison;
73-278, Clark Oil, 73-464 through 73-468, Commonwealth Edison; 74-32,
Trojan; 74-50, Pow-Wow Club; 74-68, City of Polo; 74-75, Great Lakes
Carbon; 74-118, Greenlee Bros.; 74-136, Hughes; 74-141, Acme Barrel;
74-143, Master Tank; 74-150, Western Ill. Power; 74-174 Apple River
Chemical; 73-383, Scheutte v. Korsmeyer.

An opinion and order was adopted in #73-393, Wilson & Bailey by a vote
of 4-1. Mr. Dumelle dissented believing the penalty should be higher.

An order was adopted in ##74-5, 73-61, 74-51, Alton Box Board and
Laclede Steel by a vote of 4-1, Mr. Seaman dissenting. Mr. Henss will
prepare an order. Mr. Dumelle will prepare an opinion for consideration
at a future Board meeting.

In #74-34, Granite City, verbal motion was made by Ms. Leah Hamilton,
attorney for petitioner, for an interim variance to and including September
17, 1974 and a conditional waiver was filed. The Board voted 5-0 to
allow the interim variance and ordered that any available transcripts
be filed. Mr. Henss will prepare an order.

Motion to dismiss in #73-409, Hyon was allowed by a vote of 5-0, Mr.
Marder will prepare an order.

Motion to dismiss in #73-198, Midway v. Kane was assigned to Mr. Seaman
for a draft proposal to be considered on July 25, 1974.

In #73-470, E. St. Louis & Interurban Water Co. , the Clerk was asked to
request the Hearing Officer to schedule hearings.

Motion for leave to file reply memorandum by respondent in #74-140, Western
Piece Dryers was granted and prior Board Order denying a motion to
strike was reaffirmed by a vote of 5-0. Mr. Henss will prepare an order.

Motion to consolidate and continue in #74-178, City-wide Services
was granted by a vote of 5-0. Mr. Henss will prepare an order.

Motion to dismiss in #74-185, Intercraft was granted by a vote of 5-0.
Mr. Dumelle will prepare an order.

Motion for consolidation in #74-192, Illinois Brick was granted by a vote
of 5-0. Mr. Dumelle will prepare an order.

Objection and motion for hearing in #74-197, Walworth Co. was denied by a
vote of 5-0, Mr. Dumelle will prepare an order.
