MINUTES OF REGULAR MEETING  
August 29, 1974

All Board Members were present.

Opinions and Orders were adopted by a vote of 5-0 in these cases: ##73-3, O'Connor v. Rockford; 74-151, Bensenville; 74-212, Sherwin-Williams; 74-290, Galva Foundry; 74-5, 73-61, 74-51, Alton & Laclede (opinion only).

A hearing was authorized in #73-425, Barrington by a vote of 3-2. Mr. Marder and Mr. Dumelle dissented. Mr. Seaman will prepare an order.

The Board adopted orders in these regulatory proceedings by a vote of 5-0: ## R70-17, DuPage; R72-9, Feedlots; R73-11,12, NPDES, Sub Part A and Procedural Rules amendments. Sub Part B of NPDES will be considered on September 5, 1974.
