Motion for modification in #74-272, City of Carthage was allowed by a vote of 4-1, Mr. Dumelle dissented. Mr. Seaman will prepare an order.

Petition for leave to intervene in #74-324, Tri-County Landfill was referred to the Hearing Officer for ruling.
