MINUTES OF REGULAR BOARD MEETING
January 5, 1978 Chicago, Illinois

ALL BOARD MEMBERS WERE PRESENT.

Opinions and Orders were adopted in these cases by a vote of 5-0: ##77-166, People v. Waste Management; R73-11-12, NPDES Amendments (Opinion Only); R74-15,16, Cyanide (order for publication); R75-11, Motor Racing Noise (Order for publication).

Motion for continuance in #76-316, S. DuPage was granted and the Hearing Officer asked to report on the status by a vote of 5-0. Mr. Dumelle will prepare an Order.

A letter requesting an extension in #74-234, American Brick was dismissed by a vote of 5-0. Mr. Young will prepare an Order.

Motion for continuance in 75-218, Epperson was granted by a vote of 5-0. Dr. Satchell will prepare the Order.

Request to decide without hearing was granted in #77-228, NSSD by a vote of 5-0. Mr. Goodman will prepare an Order.

Request to waive hearing in #77-272, Hemphill was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

First amended Petition in #77-288, Owens-Illinois was allowed by a vote of 5-0. Mr. Young will prepare an Order.

Motion to dismiss in #77-293, Decatur was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

In 77-334, Allaert Rendering, Motion to consolidate was denied by a vote of 5-0. Motion to Strike was denied by a vote of 3-2, Mr. Young and Mr. Dumelle dissented. Mr. Goodman will prepare the Orders.

Agreed motion to stay in 76-283, White Fence Farm was dismissed as moot by a vote of 5-0. Mr. Dumelle will prepare an Order.

An Opinion and Order was adopted in #77-52, Wilson by a vote of 4-1. Mr. Young dissented.

An Opinion and Order was adopted in 77-207, Winfield by a vote of 4-0, Dr. Satchell abstained.

In amended petitions these actions were taken: #77-189 Republic Steel, dismissed. Mr. Dumelle will prepare an Order; 77-301, Foster Grant, held for an agency recommendation; 77-306, Shell Oil Hearing authorized.

Motion to dismiss in #77-318, Harvel was denied by a vote of 5-0. Mr. Goodman will prepare an Order.

An Opinion and Order was adopted in #77-52, Keathen Wilson by a vote of 4-1. Mr. Young dissented.

An Opinion and Order was adopted in #77-207, Winfield by a vote of 4-0. Dr. Satchell abstained.

These cases were discussed and held for further discussion or possible decision on January 19, 1978: ##76-30, Dupont; 77-115, W. Chicago; 77-285, Collier Carbon; 75-411, 433 and 76-31, Rock Island.

Parties were present and made statements with regard to these citizen filed enforcement actions: ##77-320, WIPE v. EPA and Winnetka; 77-328, Svoboda v. DuPage; 77-330, Guildan v. Village of Palos Park. Briefs were allowed to be filed in #77-320 and the case was held to January 19; #77-328 was ordered held to January 19; #77-330 was held to February 2, 1978.

Owens-Illinois, hearing mandatory; 77-347, Commonwealth Edison, hearing authorized; 77-349, Central Illinois Utility, hearing authorized; 78-1, West Dundee, hearing authorized; 78-2, Dwight Center, held for Agency recommendation; 78-3, Algonquin, hearing authorized; 78-4, EPA v. Murrell, hearing mandatory; 78-5, DeKalb, additional information requested, Order by Mr. Dumelle.

All matters not disposed of as listed were ordered placed on the agenda for possible consideration on January 19, 1978.
