Minutes of Regular Board Meeting
June 7, 1979 Chicago, Illinois

All Board Members were present.

Opinions and Orders were adopted in these cases by a vote of 5-0: ##78-283 and 78-284, Southern Illinois Minerals; 79-53, Triple T Inns (Order only); 79-56, Lissner Corp.

An Order was adopted in #77-188, Burrows, regarding a motion for rehearing or modification by a vote of 4-1. Mr. Young will prepare an Order.

Motion to allow interlocutory appeal in #78-177, Celotex, was denied by a vote of 5-0. Mr. Dumelle will prepare an Order.

Joint motion to stay in #78-285, Commonwealth Edison, was granted and motion to dismiss stayed by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion to dismiss in #79-21, Brettman v. Calahan, was ordered taken with the case by a vote of 4-1, Mr. Young dissented. Mr. Goodman will prepare an Order.

Motion to file recommendation in #79-43, American Hoechst, was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to continue in #79-52, DuPage v. E.E. Hauling, was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Orders of modification were adopted in ##79-55 and 79-104, Interlake, modifying prior Orders entered on May 24, 1979 regarding hearings. The vote was 5-0, Mr. Goodman will prepare the Orders.

Motion for leave to file a motion to strike in #79-61, Illinois Power, was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to dismiss in #79-90, Monsanto, was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to extend time in #79-91, Effingham et al was granted by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion to extend time to file recommendation in #79-106, DuPont, was granted by a vote of 4-0. An objection was filed and a hearing was authorized. Mr. Dumelle will prepare an Order. Mr. Young abstained.

An Order was adopted by a vote of 5-0 which severed regulatory proceedings R78-10, Steel Mills and R78-11, Fugitive Dust from R79-3, Permit Conditions. The comment period in all proceedings was extended to June 18, 1979. Mr. Goodman will prepare an Order.

Opinions and Orders were adopted in these cases by a vote of 5-0: ##78-219, Marathon Oil; 78-258, K.L. Oil (Interim Order); 78-312, Consolidation Coal.

Beckwith, hearing mandatory; 79-117, The Eureka Co., held for Agency recommendation; 79-118, MGM Development, held for Agency recommendation; 79-119, Illinois Power Co., dismissed, Order by Mr. Goodman.

All matters not disposed of as listed were ordered placed on the agenda for possible consideration on June 21, 1979.
