Minutes of Regular Board Meeting
October 4, 1979 Chicago, Illinois

All Board Members were present.

Opinions and Orders were adopted in these cases by a vote of 4-0: ##78-258, K & L Oil; 78-266, Kerr Glass; 79-75, Canfarelli v. Romeoville; 79-101, Allied Chemical (Opinion only), Mr. Werner concurred; 79-110, Dutton v. Crest Hill; 79-138, Sanitary District of Rockford (Order only); 79-144, Morrison, Mr. Dumelle concurred; 79-163, Corporate West (Opinion only); 79-171, Rossmoor (Order only).

Motion for extension of time to respond to motion for remand in #79-6, General Motors, was granted by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motion for reconsideration in #79-130, Windsor, was denied by a vote of 4-0. Dr. Satchell will prepare an Order.

An Opinion and Order was adopted in #79-173, Village of Bethany, by a vote of 3-0, Dr. Satchell abstained.


An Order only was adopted in #79-183, Savanna Army Depot, by a vote of 4-0.
