Minutes of Regular Board Meeting  
November 1, 1979 Chicago, Illinois

All Board Members were present.

Opinions and Orders were adopted by a vote of 4-0:  
##78-149, Ogle County v. Browning-Ferris; 78-256, Danekas;  
79-72, Travieso v. Highland Hills; 79-73, Simmons;  
79-120, Stanadyne, (Order only); 79-158, Oneida.

An Opinion and Order were adopted in R78-1, Carbon Monoxide, by a vote of 4-0.

An Opinion only was adopted in R78-11, Fugitive Dust, by a vote of 3-1, Mr. Dumelle concurred and Mr. Werner dissented.

R79-4, Watercraft Grain Loading, was dismissed by a vote of 4-0. Dr. Satchell will prepare an Order.

Motions for reconsideration in ##76-80 and 77-334, Allaert Rendering, were denied by a vote of 3-1, Mr. Werner dissented.

In. #79-6, General Motors, motion for remand was denied and motion to strike declared moot by a vote of 4-0. Mr. Dumelle will prepare an Order.

A second objection was withdrawn and hearing ordered cancelled in #79-47, Travenol.

Motion to withdraw was granted in #79-65, Stauffer, by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motion for continuance in #79-79, Monmouth, was granted by a vote of 4-0. Mr. Dumelle will prepare an Order.

An Order was adopted on a motion to review a Hearing Officer Order in #79-98, Lombard, by a vote of 4-0. Mr. Dumelle will prepare an Order.

Motion to dismiss in #79-143, Thompson, was granted by a vote of 4-0. Mr. Goodman will prepare an Order.

Motion to extend time to file response in #79-166, Shell Oil, was granted by a vote of 4-0. The Board also ratified the Order granting an extension of time to file recommendation. The Order was entered on October 18, 1979. Mr. Goodman will prepare an Order.

Motion to dismiss in #79-167, Continental Grain, was ordered taken with the case by a vote of 3-1, Mr. Goodman dissented. Mr. Dumelle will prepare an Order.

Motion to decide without hearing was granted in #79-178, Round Lake Park, and the hearing cancelled. No written Order was entered.

Motion to withdraw was granted in #79-182, Addison, by a vote of 4-0. Mr. Goodman will prepare an Order.

Motion for consolidation in ##79-188,-189,-190,-191, Caterpillar, was granted by a vote of 4-0. Mr. Goodman will prepare an Order.

Motion to dismiss in #79-196, Lisle, was denied and Petitioner's response was construed as an amended petition, by a vote of 4-0. Mr. Dumelle will prepare an Order.

An objection was filed and a hearing authorized in #79-204, Normal, by a vote of 4-0.

An amended petition in #79-172, Arthur Light, was ordered held for Agency recommendation

Ammended petitions in #79-146, Sahara Coal and #79-204, Town of Normal, were ordered set for hearing.

An Opinion and Order was adopted in #79-169, Sterling, by a vote of 4-0.

An Opinion and Order were adopted in #79-175, Hoerner Waldorf , by a vote of 3-0. Mr. Goodman abstained.

An Opinion only was adopted in #79-148, Jarvis, by a vote of 4-0.

Village of Creve Couer, hearing mandatory; 79-219, Dept of the Navy, additional information requested, Order by Mr. Dumelle; 79-220, EPA v. Village of Thornton, hearing mandatory; 79-221, Continental Grain, held for an Agency recommendation; 79-222, Village of Rockdale and 79-223, Village of Carmi, dismissed, Orders by Mr. Dumelle; 79-224, City of Peoria, 79-226, Mt. Vernon and 79-227, Benton, held for Agency recommendations.
