MINUTES OF REGULAR MEETING
MAY 1, 1980 CHICAGO, ILLINOIS

All Board Members were present.

Opinions and Orders were adopted in these cases by a vote of 5-0: ##79-86, Philipsborn; 79-208, Springerton; 79-264, Bergman, Opinion only, Mr. Dumelle concurred; 80-8, Pinckneyville; 80-19, Mississippi River Grain, Mr. Dumelle may file a supplemental statement; 80-26, Hartsburg; 80-30, Wataga; 80-37, White County's Evergreen;

Orders were adopted in these cases by a vote of 5-0: ## 80-28, E. Peoria; 80-29, E. Peoria; 80-69, Department of Transportation.

An Opinion and Order was adopted in R77-12, Docket C, Water Pollution Regulations Amendments, by a vote of 5-0.

An Order was adopted in #78-296, Peabody Coal, on a motion for rehearing by a vote of 5-0. Dr. Satchell will prepare the Order.

An Order was adopted allowing an amended motion for reconsideration to be filed in #79-77, Randolph County Land-fill, by a vote of 3-2. Mr. Goodman and Dr. Satchell dissented. Mr. Werner will prepare an Order.

Motion for modification and amendment filed in #79-124, Wagner, was ordered given a new case number and additional information requested. The vote was 5-0, Dr. Satchell will prepare an Order.

An Order was adopted on a motion for reconsideration in #79-145, Celotex, by a vote of 4-0, Mr. Werner abstained. Mr. Goodman will prepare an Order.

Motion for reconsideration in #79-154, Winslow, was denied by a vote of 5-0. Mr. Werner will prepare an Order.

Motion to stay was granted in #79-160, U.S. Steel, by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion to strike in #79-179, U.S. Steel, was ordered taken with the case.

Motion for stay in #80-3, Caterpillar Tractor, was granted by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion for extension of time to respond in #80-12, Safety-Kleen, was granted by a vote of 4-0. Mr. Dumelle was out of the room for the vote. Dr. Satchell will prepare an Order.

An Order was adopted in #80-42, Kraft, on a motion to compel and motion to stay by a vote of 4-0. Mr. Dumelle was out of the room for the vote. Dr. Satchell will prepare an Order.

Motion to dismiss was denied in #80-46, Kaji v. Olson, by a vote of 4-1, Mr. Werner dissented. Mr. Goodman will prepare an Order.

Motion to dismiss was granted in #80-52, Sauget, by a vote of 5-0. Dr. Satchell will prepare an Order.

An Order was adopted in #80-60, Hillside, on a motion to dismiss by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion to dismiss in #80-50, Pulte Homes, was granted by a vote of 4-0, Mr. Werner abstained. Mr. Goodman will prepare an Order.

An amended petition in #80-44, Riverton, was held to May 15, 1980 for consideration.

Since objections had been filed a hearing was authorized on an amended petition filed in #80-47, Knoxville.

The amended petition filed in #80-55, Medusa Aggregates, was ordered held for an Agency recommendation.

These cases were discussed and held to May 15, 1980 for further discussion or possible decision: ##78-305, Glen's Restaurant; 79-44, Mt. Carmel; 79-179, U.S. Steel; 80-9, Nadelhoffer-Wilson; 80-43, Derby Meadows; R76-20, R77-10, Mine Waste Amendments; R79-13, WQS Amendments.

Minutes of Board Meetings held January 10, 24, February 7 and 21, 1980 were approved as amended by a vote of 4-0. Mrs. Anderson abstained.

These news cases were ordered held for Agency recommendations: ##80-79 and 80-80, Knoxville.

A hearing was authorized in #80-82, C. Iber & Sons and the City of Monmouth was ordered joined as a party. The vote was 5-0, Mr. Goodman will prepare an Order.

Additional information was requested in #80-83, St. Clair County Housing Authority, and the Metro-East Sanitary District was ordered joined as a party. The vote was 5-0, Mr. Goodman will prepare an Order.

#80-84, Larchmont Water Corp. was dismissed by a vote of 5-0. Mr. Goodman will prepare an Order.

These cases were held pending receipt of additional information: ##80-85, Allis-Chalmers, Order by Mr. Goodman; 80-86, Belvidere, Order by Mr. Dumelle; 80-91, Norris City Sanitary District, Order by Mr. Goodman.

A hearing is mandatory in #80-87, EPA v. Missouri-Pacific R.R. Company and International Minerals and Chemical Corp.

Hearings were authorized in #80-89, Central Illinois Light Co. (Wallace Station) and #80-90, Central Illinois Light Co. (Edwards Station).

#80-88, Illinois Department of Transportation, Highland Park, was held to May 15, 1980 for possible action.

An Order was adopted in #80-92, Allied Chemical and Inverness Mining Co. by a vote of 5-0. Dr. Satchell will prepare the Order. An Opinion will be considered at a later date.

R80-6, Water Pollution Regulations Amendments, Rules 104 and 951, were authorized for publication and comment by a vote of 4-0. Mr. Werner abstained.

R80-7, Procedural Rules Amendments, Rules 502(a) and 503(a), were authorized for hearing and publication by a vote of 5-0.

Barbara Sidler addressed the Board on general matters of concern to the Environmental Protection Agency.

The Board voted to renew the court reporting contract with Longoria and Goldstine for FY81 by a vote of 5-0.

All matters not disposed of as listed were ordered held for possible consideration on May 15, 1980.
